Active Database Software ("LICENSOR") agrees to provide the end user ("END USER") with a copy of this software product ("SOFTWARE"), and grants the END USER a limited license to use the SOFTWARE. LICENSE OF UNREGISTERED SOFTWARE

An unregistered copy of the SOFTWARE ("UNREGISTERED SOFTWARE") may be used by the END USER for non-commercial purposes, copied and distributed as long as it is not sold, and all original files are included, including this license. The END USER is NOT allowed to make a charge for distributing this Software (either for profit or merely to recover your media and distribution costs) whether as a stand-alone product, or as part of a compilation or anthology, without explicit prior written permission.

LICENSE OF REGISTERED SOFTWARE

A registered copy of the SOFTWARE ("REGISTERED SOFTWARE") allows the END USER to use the SOFTWARE installed on a single location by one user at a time. The Desktop version of the SOFTWARE can be installed on a non-removable drive of the END USER computer to a non-shared folder. The Portable version of the SOFTWARE can be installed to any drive of the END USER computer, to a network drive, or to folder that is shared among several END USER computers.
