

## END-USER LICENSE AGREEMENT FOR Antenna House PDF API

**IMPORTANT. READ CAREFULLY:** This License Agreement (EULA) is a legal agreement between End User and Antenna House, Inc. for the Antenna House PDF API which includes computer software and online documentation (Product).

By installing, copying, or otherwise using the Product, the Customer agrees to be bound by the terms of this Agreement. If the Customer does not agree to the terms of this Agreement, do not install or use the Product. The Product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Product is licensed, not sold.

### 1. GRANT OF LICENSE.

Antenna House grants the Customer the perpetual right to use the Product under following conditions.

#### 1.1 Type of computer

- The Customer may install the Product into a (Server \_ or \_ Standalone / Client computer.)

#### 1.2 Number of computers

- The maximum number of computers into which the Product is installed shall not exceed ( **x** ).

#### 1.3 Serial Number

- The Serial Number of the Product is (provided upon purchase)

### 2. Maintenance of the Product

a. The Maintenance Period Antenna House supplies to the customer:

(a) Free Maintenance Period is 90 days from purchase date of Product.

(b) The Maintenance period.

START: **10/2021** (MM/YYYY)

END : **10/2022** (MM/YYYY)

b. Maintenance of the Product will be supplied to Customer by Antenna House when purchased directly from Antenna House or through a Reseller.

c. In the event the Customer identifies any important bugs in the Product within Maintenance Period, Antenna House shall revise the Product at no expense to the Customer and provide the Customer with the Product as a maintenance release. Important bugs are defined as ones which prevent or impede the expected functionality of the product

### 3. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

- The Customer may not copy, deliver or distribute the Product without a written permit from Antenna House.

- The Customer may not reverse engineer, decompile, or disassemble the Product, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

- The Customer may not sell, rent, or lease resell, or otherwise transfer for value, the Product.

- Termination. Without prejudice to any other rights, Antenna House may terminate this Agreement if the Customer fails to comply with the terms and conditions of this Agreement. In such event, the Customer must destroy all copies of the Product and all of its component parts.

- Antenna House will give the Customer notice and 30 days to correct above before the contract will be terminated.

### 4. COPYRIGHT.

The Product is protected by copyright and other intellectual property laws and treaties. Antenna House owns the title, copyright, and other intellectual property rights in the Product.

## 5. LIMITATION OF LIABILITY AND REMEDIES

Notwithstanding any damages that the Customer might incur for any reason whatsoever (including, without limitation, all damages referenced above and all direct or general damages), the entire Liability Antenna House under any provision of this Agreement and the Customer's exclusive remedy for all of the foregoing shall be limited to the amount paid for the product, unless such limitation is prohibited by law. The foregoing limitations, exclusions and disclaimers shall apply to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

## 6. SEVERABILITY

If any provision of this End User License Agreement (EULA) is found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this EULA and shall not affect the validity and enforceability of any remaining provisions. Furthermore, in lieu of such unlawful, void, or unenforceable provision, a suitable legal, valid, and enforceable provision that approximates the intent and economic effect of the invalid or unenforceable provision shall be added to this EULA. This substitution shall be made in a manner that preserves, to the maximum extent possible, the original intentions of the parties as reflected in the original provision.

## 7. MEDIATION

Any disputes arising out of or related to this End User License Agreement (EULA) or the use of the software shall be exclusively resolved through mediation in the State of Delaware, USA, prior to the commencement of any litigation. This jurisdiction applies regardless of the customer's location. If mediation is unsuccessful, the dispute shall then be submitted to the courts located within the State of Delaware for resolution. This clause shall govern all legal actions without regard to conflict of law principles.
