## END-USER LICENSE AGREEMENT FOR APPS 365 SHORT URL

**IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS  
LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH  
THIS PROGRAM INSTALL:**

APPS 365 LTD End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and APPS 365 LTD.
