

END-USER LICENSE AGREEMENT

IMPORTANT! BE SURE TO CAREFULLY READ AND UNDERSTAND ALL OF THE RIGHTS AND RESTRICTIONS SET FORTH IN THIS END-USER LICENSE AGREEMENT ("EULA"). YOU WILL BE ASKED TO REVIEW AND EITHER ACCEPT OR NOT ACCEPT THE TERMS OF THE EULA. YOU ARE NOT AUTHORIZED TO USE THIS SOFTWARE UNLESS AND UNTIL YOU ACCEPT THE TERMS OF THIS EULA.

This EULA is a binding legal agreement between you (hereinafter the "Licensee" or "YOU") and AutoDWG (hereinafter the "Licensor") for the materials accompanying this EULA, including the accompanying converter software and may include associated media, printed materials and any "online" or electronic documentation (hereinafter the "SOFTWARE"). By installing the SOFTWARE, the Licensee agrees to be bound by the terms of this EULA. If the Licensee does not agree to the terms of this EULA, do not install or attempt to use the SOFTWARE.

1. Grant of License

The SOFTWARE is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE is licensed, not sold. This EULA grants the Licensee the following rights:

This SOFTWARE is for single user access only. Additional licenses must be purchased for multi-user access.

The Licensee may store or install a copy of the SOFTWARE on a storage device, such as a network server, used only to run the SOFTWARE on another Computer over an internal network. The Licensee must, however, acquire a license for each separate Computer on which the SOFTWARE is run, displayed or utilized from the server or similar device. A license for the SOFTWARE may not be shared or used concurrently on different Computers.

The Licensee may install, use, access, display and run only one copy of the SOFTWARE, on a single Computer, workstation or terminal (hereinafter the "Computer"). The primary user of the Computer on which the SOFTWARE is installed may make a second copy for his or her exclusive use for archival or backup purposes only.

The Licensee may transfer his or her license from one Computer to another provided it is used on only one Computer at any one time and any Computer on which it is used is under Your custody and control at the time of use.

The license rights under this EULA are non-exclusive. All rights not expressly granted herein reserved by Licensor.

The Licensee may not sell, transfer or convey the SOFTWARE to any third party without Licensor's prior express written consent.

In consideration of payment of the License fee, which is a one-time fee of the price YOU pay, AUTODWG grants to the Licensee through this EULA permission to use the SOFTWARE,

The Licensee free grants the Licensee the following rights:

(1) Life-time valid license code

(2) One-year of free upgrade service.

After the one year of free-updating period the Licensee can still use the converter and the Licensee can use the Licensee last free-upgraded version for lifetime as the Licensee hold the license code which will not expire from the time the Licensee purchased the converter. The Licensee need to purchase the upgrade for the next one-year of upgrades and this is totally optional.

(3) Life-time free tech-support service,

(4) No limitations for the number of files created,

(5) No restrictions of the converted files' distributions,

2. Replacement, Modification and/or Upgrades

Licensor may, from time to time, and/or for a fee, replace, modify or upgrade the SOFTWARE. When accepted by the Licensee, any such replacement or modified SOFTWARE code or upgrade to the SOFTWARE will be considered part of the SOFTWARE and subject to the terms of this EULA (unless this EULA is superseded by a further EULA accompanying such replacement or modified version of or upgrade to the SOFTWARE).
