

## **AutoDWG Component End User License Agreement (EULA)**

Effective Date: 2026/06/01

### **1. Parties & Acceptance**

This End User License Agreement ("Agreement") is a legally binding contract between:

**Licensor:** AutoDWG

**Licensee:** The individual, enterprise or legal entity purchasing, downloading, integrating or using AutoDWG CAD software components (hereinafter referred to as "Licensee").

By downloading, installing, activating, integrating, running or paying for AutoDWG components, Licensee unconditionally accepts all terms set forth in this Agreement. If Licensee disagrees with any clause herein, Licensee must delete all component files immediately and shall not proceed with payment or license activation.

### **2. Definitions**

**2.1 Component:** All AutoDWG proprietary CAD libraries, DLLs, APIs, runtime binaries, conversion modules, sample code, technical documentation and help manuals provided by AutoDWG.

**2.2 Perpetual License:** One-time paid permanent runtime authorization. The specific component version unlocked by the license key can run indefinitely with no built-in expiry date.

**2.3 Developer OEM License:** Seat-based license for named developers. It is authorized for internal coding, testing, embedding components into Licensee's own

independent software, and commercial OEM redistribution to Licensee's end customers. **Resale of standalone raw AutoDWG components is prohibited.**

**2.4 Server License:** Licensed per physical or virtual server instance. This license is designed for unattended background services, 24/7 automated batch CAD conversion and headless backend integration without graphical user interface.

**2.5 Enterprise License:** A high-tier commercial license category above Developer License and Server License, divided into two official sub-tiers for large-scale corporate deployment:

**2.5.1 Enterprise Site License:** Valid exclusively for one single legal entity and one registered physical business location. It grants unlimited developer seats, unlimited server instances and unrestricted internal deployment only within the licensed site address. This license is not applicable to subsidiaries, remote branches, external factories or overseas premises.

**2.5.2 Enterprise Global License:** Top-tier group-wide enterprise authorization. It covers the contracting parent entity plus all wholly-owned, controlled subsidiaries, domestic and overseas factories, branch offices and affiliated group companies globally. It allows unlimited developer seats, unlimited server instances and unrestricted cross-region, cross-country deployment across the entire corporate group structure.

**2.6 Maintenance & Support (M&S):** Optional annual paid service, including version upgrades, bug fixes, format compatibility patches, technical support and remote debugging. The fixed annual maintenance rate is **20% of the original perpetual license purchase price.**

**2.7 Lapsed Maintenance:** The status that maintenance fees remain unpaid for one full consecutive calendar year or longer.

### **3. License Grant & Usage Scope**

### 3.1 General Perpetual Runtime Right

All license tiers provided by AutoDWG are perpetual. After full payment and license key activation, Licensee may run the activated Component version permanently, with no mandatory recurring runtime fees.

### 3.2 Developer OEM License Restrictions

1. Usage is strictly limited to the contracted number of named developer seats for development, integration and quality testing workflows.

2. Licensee may embed the Component into its finished independent software for commercial sale to third-party end users.

3. Licensee shall not sublicense, rent, lease or distribute standalone AutoDWG Component binaries to any external parties independently.

### 3.3 Server License Restrictions

1. Authorization is valid only for the exact quantity of purchased server instances. Cloning virtual instances, splitting deployments or expanding to additional servers requires written approval from AutoDWG and supplementary licensing fees.

2. This license is optimized for factory automation, ERP/MES integration and high-volume unattended batch conversion pipelines.

### 3.4 Enterprise Site License Restrictions

1. Unlimited internal development, testing and production deployment is permitted solely at the registered single-site address of the contracted legal entity.

2. This license covers all Component modules purchased under the same Enterprise Site contract.

3. Deployment at subsidiaries, remote sites or separate legal entities requires a formal upgrade order and additional licensing costs.

### 3.5 Enterprise Global License Restrictions

1. Full unlimited deployment rights extend to the parent contracting company and all group-wide subsidiaries, branches and international locations.

2. All purchased Component modules are authorized for use by every entity within the licensed corporate group.

3. No additional site or server licenses are required for any affiliated group locations covered under this Global Enterprise agreement.

### 3.6 Universal Prohibited Activities

Licensee shall not perform any of the following acts under any circumstances:

1. Reverse engineer, decompile, disassemble, crack or alter Component binaries, encryption protocols or license validation logic;

2. Assign, transfer, sublicense or resell full or partial license rights without the signed written consent of AutoDWG;

3. Deploy unlicensed extra developer seats, servers or cross-site instances beyond the contracted scope.

## **4. Maintenance, Upgrade & Support Policy**

4.1 Maintenance service is fully optional. Licensee may run the purchased and frozen component version permanently without paying maintenance fees. Maintenance is not a mandatory cost for component operation.

**4.2 The standard annual maintenance fee is fixed at 20% of the original perpetual license payment amount,** and invoices are issued yearly in advance.

4.3 Entitlements of Active Maintenance:

- Full major & minor version releases, new feature updates and CAD format compatibility patches

- Critical bug fixes and stability updates

- Priority email technical support

4.4 Core Lapsed Maintenance Rule (Non-Negotiable) (1) If maintenance expires and remains unpaid for 1 full consecutive year or longer, the existing perpetual component version will continue running permanently with no lockout. (2) No backdated catch-up payments, partial reactivation fees or discount reinstatement options are available to restore version updates and technical support after a 12+ month lapse. (3) The only valid way to obtain new versions, patches and active technical support after long-term lapse is to purchase a brand-new full perpetual license at AutoDWG's current official published pricing.

## **5. Payment, Delivery & Refund Terms**

5.1 License activation keys and component download links will be delivered electronically immediately after AutoDWG receives full cleared payment.

5.2 All license fees and maintenance fees are non-refundable once license keys are dispatched.

5.3 Published pricing for new licenses is subject to adjustment without prior notice. The runtime rights of existing perpetual licenses will not be repriced retroactively.

## **6. Warranty & Liability Limitation**

6.1 AutoDWG warrants that the Components operate substantially in line with official public product documentation at the time of purchase.

6.2 No implied warranty is provided for custom industrial, manufacturing, OEM or production workflows. Licensee shall complete the free full-function trial with its actual production drawings to verify applicability before making paid purchases.

## **7. Termination**

7.1 AutoDWG reserves the right to immediately terminate this Agreement and revoke all license rights if Licensee materially breaches any core clauses, including but not limited to reverse engineering, unauthorized redistribution, unlicensed over-deployment and serious payment default.

7.2 Upon termination, Licensee must fully uninstall and permanently erase all copies of AutoDWG Component from all servers, workstations, development devices and storage media. All perpetual runtime privileges will be fully revoked simultaneously.

## **8. General Legal Clauses**

8.1 Amendments: Any changes, waivers or supplementary addendums to this Agreement shall take effect only with the signed written approval of authorized representatives of both parties. Verbal commitments shall have no legal force.

8.2 Severability: If any single clause is ruled unenforceable by a court or arbitrator, all remaining clauses shall remain fully valid and enforceable.

8.3 Entire Agreement: This EULA supersedes all prior oral, email, quotation or draft discussions between both parties in relation to AutoDWG component licensing.
