SOFTWARE LICENSE TERMS

1 GRANT OF LICENSE

Intelligent Converters grants you a non-exclusive, non-transferable right to use the Software Product. "Use" means storing, loading, installing, executing or displaying the Software Product.

If you have acquired this License Agreement with the demo version of Software Product, you are granted the right to use unlimited number of copies in the manner specified above. Also Intelligent Converters allows redistribution of the demo version, provided you do not infringe the copyright.

2 DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS

2.1 Not for Resale Software. You may not resell, or otherwise transfer for value, the Software Product.

2.2 Rental. You may not rent, lease, or lend the Software Product.

2.3 Limitations on Reverse Engineering, Decompilation, and Disassembly. You may not reverse engineer, decompile, or disassemble the Software Product, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

2.4 Proprietary notices. You may not remove any proprietary notices or labels on the Software Product.

2.5 Termination. Intelligent Converters may terminate your license upon notice for failure to comply with any of these License Terms. In such event, you must immediately destroy all copies of the Software Product and all of its portions in any form.

2.6 Support Services. Intelligent Converters provides you with unlimited e-mail support services related to the Software Product. 3 SOFTWARE LICENSES

3.1 SINGLE USER LICENSE allows clients to install the software product on exactly one (1) computer system. Client can store a backup copy of the software but cannot use two copies of the software at any one time. Single-User License does NOT allow to make use of the software through a corporate network.

3.2 CORPORATE LICENSE allows a single company to install the software product on an unlimited number of machines within that corporation. All machines must be owned, leased, or used for the purpose of the purchasing company. Corporate License does NOT allow to redistribute the software product or include it into software products that the company sells.

3.3 REDISTRIBUTION LICENSE grants you the rights to redistribute your applications with Software. There is no redistribution fee for users of such applications, and there are no royalties for selling such applications. You may use or redistribute the Software components on any computer or workstation provided that:

(a) You distribute the Software only in conjunction with and as an integral part of your application

(b) You do not expose, document or make public the Software components API (Application Programming Interface)

(c) Your end users are not allowed to use the Software for development purposes

(d) You do not wrap or distribute the Software in a component that can be used for software development purposes on any application, tool, environment or container

(e) You do not distribute (parts of) the Software beyond the code being part of the program to a third party

(f) Your software product must not compete with Intelligent Converters products

(g) You agree to indemnify, hold harmless, and defend Intelligent Converters from and against any and all claims or lawsuits including attorney's fees that arise or result from the use or distribution of your application
