END-USER LICENSE AGREEMENT FOR Deltabit (Pty) Ltd

IMPORTANT-READ CAREFULLY: This End-User license Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Deltabit (Pty) Ltd for the use of Deltabit (Pty) Ltd products, which include computer software and may include "online" or electronic documentation ("SOFTWARE PRODUCT" or "SOFTWARE"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. THIS PRODUCT IS NOT RETURNABLE.

THIS SOFTWARE OR ANY OF ITS COMPONENTS AND SAMPLE FILES MAY NOT UNDER ANY CIRCUMSTANCES BE PLACED ON ANY DIRECTORIES THAT ARE SHARED BY THE GNUTELLA PROTOCOL, OR ANY SIMILAR SERVER BASED OR PEER BASED FILE SHARING PROTOCOLS OR SYSTEMS.
