By installing, copying, or otherwise using the DEVEXPRESS THEME DESIGNER, you agree to be bound by the terms of this EULA. If you do not agree to any part of the terms of this EULA, DO NOT INSTALL, USE, EVALUATE, OR REPLICATE IN ANY MANNER, ANY PART, FILE OR PORTION OF THE DEVEXPRESS THEME DESIGNER.

This AGREEMENT is the entire agreement between DEVEXPRESS and LICENSEE concerning its subject matter (including the license, access, and use of DEVEXPRESS THEME DESIGNER, and supersedes all prior and contemporaneous agreements, proposals, or representations, written or oral, concerning its subject matter.
