This is a legal agreement between you, the end user, and DEVPIA Inc.

BY CLICKING THE "YES" BUTTON OR INSTALLING OR USING DEXTUPLOAD SOFTWARE (THE "PRODUCT"), THE INDIVIDUAL OR ENTITY LICENSING THE PRODUCT ("LICENSEE") IS CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT. ## 1. LICENSE AGREEMENT

As used in this Agreement, "DEVPIA" shall mean Developer's Utopia, a.k.a. DEVPIA Inc. In this Agreement "Licensor" shall mean DEVPIA except under the following circumstance: if Licensee acquiring the Product as a bundled component of a third party product or service, then such third party shall be Licensor.

## 2. LICENSE GRANT

License grants Licensee a non-exclusive and non-transferable license to reproduce and use for personal or internal business purposes the executable code version of the Product, provided any copy must contain all of the original proprietary notices. Licensee may not redistribute the Product unless Licensee has separately entered into a distribution agreement with DEVPIA.

### **3. RESTRICTIONS**

Except as otherwise expressly permitted in this Agreement, or in another DEVPIA agreement to which Licensee is a party, Licensee may not: (i) remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the Product; (ii) sell, rent, lease, sublicense, redistribute, encumber, or otherwise transfer rights to the Product; (iii) decompile, disassemble, reverse engineer, or otherwise attempt to derive the source code for the Product (except to the extent applicable laws specifically prohibit such restriction); or (iv) modify or create any derivative works of the Product or documentation, including translation or localization.

### 4. PROPRIETARY RIGHTS

Title, ownership rights, and intellectual property rights in the Product shall remain in DEVPIA and/or its suppliers. Licensee acknowledges such ownership and intellectual property rights and will not take any action to jeopardize, limit or interfere in any manner with DEVPIA's or its suppliers' ownership of or rights with respect to the Product. The Product is protected by copyright and other intellectual property laws and by international treaties. Title and related rights in the content accessed through the Product is the property of the applicable content owner and is protected by applicable law. The license granted under this Agreement gives Licensee no rights to such content.

### 5. WARRANTY

DEVPIA warrants that the Product will perform substantially in accordance with the accompanying written materials.

# 6. Personal Information Protection

DEVPIA has a right to retain minimal customer information (product key, serial number, URL information, IP information, computer name, product version, etc) for the certification procedure of product installing and the stable customer support. We will never use the information to other uses without customer approval.

## 7. DISCLAIMER OF OTHER WARRANTIES

DEVPIA DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH RESPECT TO THE PRODUCT AND/OR THE ACCOMPANYING WRITTEN MATERIALS. THIS WARRANTY GIVES LICENSEE SPECIFIC LEGAL RIGHTS. Some countries or jurisdictions do not allow the exclusion of implied warranties so the above limitations may not apply.

# 8. LIMITATION OF LIABILITY

IN NO EVENT WILL DEVPIA BE LIABLE TO LICENSEE FOR ANY LOSS OF USE, INTERRUPTION OF BUSINESS, OR ANY DIRECT, INDIRECT SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND (INCLUDING LOST PROFITS) REGARDLESS OF THE FOR OF ACTION WHETHER IN CONTRACT, TORT(INCLUDING NEGLIGENCE), STRICT PRODUCT LIABILITY OR OTHERWISE, EVEN IF DEVPIA HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

# 9. TERMINATION

Without prejudice to any other rights, Licensor may terminate this Agreement if Licensee breaches any of its terms and conditions. Upon termination, Licensee shall destroy all copies of the Product including copies of related documentations.
