1. GRANT OF LICENSE

1.1. INDIVIDUAL DEVELOPER LICENSE

FAST REPORTS grants DEVELOPER END USER the right to use one copy of the PRODUCT for the sole purpose of the development of software applications. If the DEVELOPER END USER is an entity, it must designate one individual within its organization to license the right to use the PRODUCT in the manner provided herein.

1.2. TEAM LICENSE

FAST REPORTS grants DEVELOPER END USER the right to use the PRODUCT by the developer's team (up to four persons) for the sole purpose of the development of software applications.

1.3. SITE LICENSE
