Terms

TERM	DESCRIPTION
Report (Prepared report)	A report is a document that can be generated from a set of data obtained from any application, file, or DBMS. The report is usually generated from a pre-defined template, but it can also be built from application code. The report can be interactive and can be restructured (modified) based on user commands (manipulations). The prepared report is a generated document saved in the internal format of the report generation system. The prepared report cannot be restructured or modified, but can be exported to files of other formats.
Template	A pre-defined layout for further report generation. The template can be stored in a file, DBMS, or network resource. The report template may contain bindings to external data, their description, parameters, and script. A special program—designer—can be used for template editing.
Export	A document or file in any format, created based on a prepared report. For example, these can be PDF, Excel, JPEG files, etc. The creation of the file can be combined with its sending as an email message or storage in network repositories.
Designer	Program for creating and editing report templates. It can be installed on a computer or run in a browser (online designer).

Key features

This section will help you learn about the main features of FastReport Cloud, get acquainted with the product, and quickly jump to the article you are interested in. You can learn about FastReport Cloud in [this article](#).

Report Builder

The builder is based on the FastReport .NET report generation library, it allows you to create reports and documents according to pre-prepared templates.

Cloud Solution

The entire infrastructure is located in the cloud, just connect to FastReport Cloud from your application or open it in a WEB browser from a mobile phone or computer. Anytime. Anywhere. And you will have all reporting and document generation power.

Template and Report Management

FastReport Cloud allows you to store templates and reports in a virtual file system. You have all common file actions: upload, copy, rename, and transfer.

Sharing

You can share templates, reports, and other files via the link. The person accessing the link may have a minimal set of read-only permissions or may be allowed to edit through the Online Designer.

We will provide a detailed description of the feature later.

Multi-user work

Several users can be added to a workspace, and everyone will be able to access it, including templates, reports, data sources, and other resources.

Permission system

A flexible permission system allows you to set different access levels for team or group members. For example, one user group will be able to create new reports in the designer, and another group will be able to build and print PDF reports from templates.

Data sources

Data sources can be created directly in the FastReport Cloud infrastructure. An already configured data source gets into the report template. And from the report itself, you can connect to MySQL, MsSql, PostgreSQL, OracleDB, Json, XML, CSV.

Online designer

You can create and edit report templates on any platform and even from a mobile device.

What is FastReport Cloud?

FastReport Cloud, provided by Fast Reports Inc., is a set of cloud services that can be used by programmers, report developers, and end users. The main list of services includes:

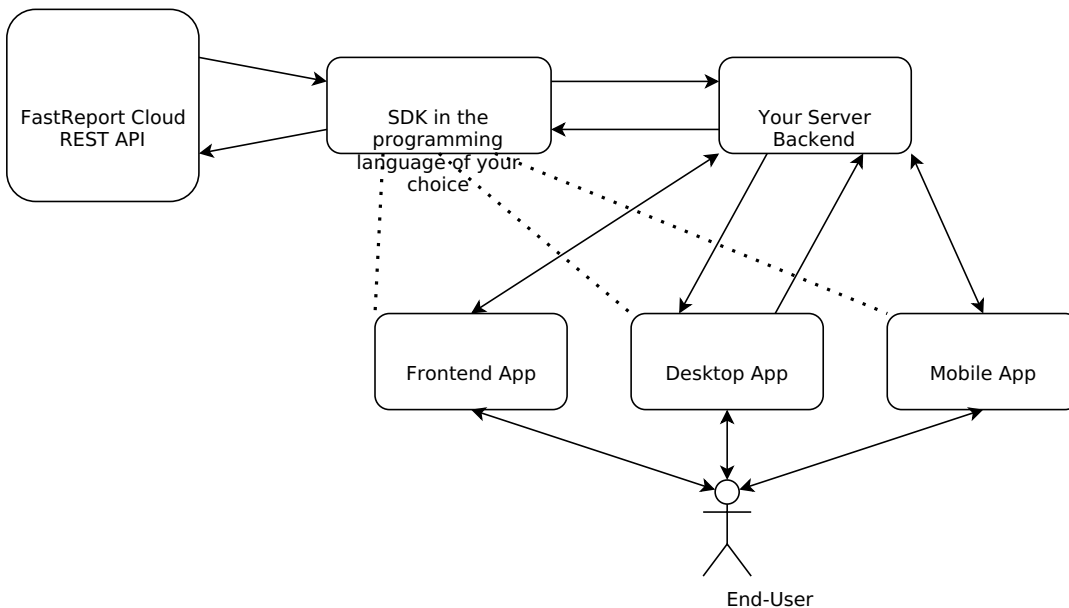
1. Storage of reports and templates (report template—internal storage format frx) with the possibility to upload, copy, move, rename, change attributes, delete, and download report files.
2. Differentiation of access permissions to user cloud resources.
3. Report builder. The service allows you to generate a report or a printed document based on a template that is located in the internal storage.
4. An Online Designer that offers to create a new template or edit an existing one.

The report builder is based on the FastReport .NET report generator library. The builder offers access to shared resources with a single service queue. This means that at the time of the request to the builder, the request will be put into the service queue and will be processed in a while.

As for the waiting time for report building, we will do our best to minimize the time and provide transparency on the waiting time and queue position.

How does FastReport Cloud work?

FastReport Cloud provides a REST API for integration into any server application. Below is an example workflow.



There is opportunity to embed in a client application, however, for security reasons, we do not recommend giving access to your account through client applications.

Let's look at a simple example of receiving a report in a PDF file by an end user. This is not the only solution to this problem, but a recommended one.

1. The end user opens the client application. It can be any application with Internet access: Android, iOS, TV, Windows, WEB, PWA...
2. The end user requests the application to view the report (PDF file).
3. The application connects to the backend server, where the connection string to the FastReport Cloud access point is specified. This approach will secure your access keys to your FastReport Cloud account.
4. The server, using FastReport.Cloud.SDK or directly with an HTTP request to the FastReport Cloud access

point via the REST API protocol, accesses the builder and requests a PDF file. Then it goes into the waiting response mode for some time.

5. The builder is processing the task.

6. The server downloads the task execution result (PDF file) and returns it to the client application.

How is FastReport Cloud different from the FastReport .NET library?

FastReport Cloud services use the FastReport .NET library, transferring the reporting load from the client application to the server cloud power. The following table shows the differences between the cloud solution and the embedded solution:

Workspace

Workspace is a unit of access to FastReport Cloud resources. To be able to create templates, build reports, work with files and use other FastReport Cloud features, you need access to the workspace.

There is a direct relationship between a cloud access subscription and a workspace. Once the subscription is paid and issued, the user will be given administrative access to the workspace.

You can connect multiple users to a workspace. The user limit is specified in the subscription plan.

Terms

TERM	DESCRIPTION
Workspace	A unit of access to FastReport Cloud resources. It contains only one subscription. The identifier matches the subscription. The workspace stores rights and user settings.
Subscription	Access to resources limited in time. Contains only one workspace. The identifier matches the workspace. It stores information about the history of subscription periods. There can be only one active period, which allows you to clearly differentiate access to resources based on the subscription plan.
Subscription period	The duration of a specific subscription plan. During the subscription period, FastReport Cloud resources are accessed according to the list specified in the subscription plan.
Subscription Plan	A set of paid resources that are accessed, as well as a set of restrictions on these resources.

Subscription plan

The subscription plan contains information about the following resources:

1. [File storage](#) limit. Separately, it shows the size of [templates](#), prepared [reports](#) and [export](#) results.
2. The maximum size of a template or report to be uploaded to FastReport Cloud, files cannot be uploaded to the export storage.
3. Time period — the time the subscription plan is valid.
4. The duration of the read-only period. Read-only mode will be enabled at the end of the subscription period. After this mode expires, the workspace will be locked.

Note! There is no access to a locked workspace, for example, you cannot download or delete files stored in FastReport Cloud. After some time, the locked workspace will be deleted automatically or at the user's request.

5. Number of [groups](#) — the maximum number of groups that can be created in the workspace.
6. The option of using [the online designer](#) — activation of the option to use the online designer in the workspace.
7. Number of [data sources](#) — specifies the maximum number of data sources that can be created for the workspace. Does not affect the number of data sources within a report.
8. Number of users (slots) — specifies the maximum number of users that can be added to one workspace.
9. Ability to use infinite pages in reports — enables or disables the ability to use infinite pages in reports. If

this feature is disabled, reports with an infinite page will be marked as invalid.

10. Number of pages in the report — specifies the maximum number of pages that can be in the report. If the number of pages exceeds the allowable one, then the report is built with the available number.
11. Access to the API task system — contains a list of tasks allowed for a call.
12. Preparing a report from a template.
13. Template export.
14. Report export.
15. Transporting the result via Email.
16. Transporting the result via Webhook.
17. Check data source.

Properties

The workspace contains the following properties:

1. Name.

For ease of identification, users can assign a name to the workspace themselves. This name will be displayed in the user panel. In addition to the workspace name, the user can also see the subscription plan name.

This property is not set by default, and the workspace will be identified by either the subscription plan name or an identifier number.

2. Root directories.

This property cannot be set manually. It stores information about the identifiers of the root directories of the virtual file system. There are 3 root directories in total: templates, reports, and exports.

3. User invitations.

In addition to manually adding users to a workspace, you can generate up to five invitations. They are used to automatically add users by link. Each invitation has an expiration date and a number of uses.

4. Default permissions.

They replace all unspecified access parameters of a resource during checks. For example, if you specify `Other.Get = Download` in the default permissions for files, then subscription users will be able to download all files. To make an exception to these rules, you need to configure access permissions to a specific resource. See the [User permissions](#) section for more information about rights.

5. Default language. It specifies which localization to use when exporting or rendering a report, for example, for the date and time format. The default language will be used if the export request or build request does not specify which locale to use.

6. Active subscription plan. Information about the active subscription. Please note that only one subscription plan can be active at a time. For example, if the old period is still valid, but a new subscription has been issued, then the old period will be archived, and the new subscription plan will be named as active.

User permissions

User permissions of the subscription are divided into 5 groups.

1. `Get` — getting information.
 1. `Entity` — getting information about subscription and workspace.
 2. `Users` — getting a list of workspace users.
 3. `Permission` — getting information about user permissions in a workspace.
 4. `RootDirectory` — getting information about the root directories of a workspace.
 5. `DataSources` — getting a list of workspace data sources.
 6. `Groups` — getting a list of workspace groups.
 7. `DefaultPermissions` — getting a list of permissions to resources for users, such as files.
 8. `Invites` — getting a list of invitations.
2. `Update` — updating any properties of a workspace.
 1. `Name` — the name of a workspace.
 2. `DefaultPermissions` — regulating default access permissions to workspace resources, such as files.
 3. `Locale` — changing the language and localization for building reports.
3. `Create` — creating or adding some information to a workspace.
 1. `DataSource` — creating a new data source.
 2. `Group` — creating a new group.
 3. `User` — adding a user to a workspace.
 4. `Invites` — creating new invitations to a workspace for users.
4. `Delete` — deleting information directly related to a subscription.
 1. `Users` — deleting a user from a workspace.
 2. `Invites` — deleting an issued invitation.
5. `Administrate` — administrative access to subscription rights.
 1. `Owner` — editing the owner of a subscription and its related rights.
 2. `Group` — editing the rights of user groups.
 3. `Other` — editing the rights of subscription users.
 4. `Anon` — editing the rights of anonymous access to a subscription.

The rights work model is the same for all cloud elements and is described in the [puser permissions](#) section.

File storage

FastReport Cloud has a cloud storage within the infrastructure with virtual file system support. The storage is divided into three types of categories, each of which has its capacity limit:

1. Report templates.
2. Reports.
3. Exports from reports.

Each category uses an isolated file system with directories and files.

There are no nesting restrictions for directories, but we recommend that you do not nest more than 3 levels. It will not work to create files and directories indefinitely since the minimum size of an empty directory and any file is 16 KB.

Basic file and directory properties

Here is a list of basic properties that are common to all directories and all storage types.

1. **Name** — display name of the file or directory.
 - The file name cannot be empty.
 - The file name cannot be longer than 250 characters.
 - The file name cannot contain the following characters: double quote `"`, less-than sign `<`, greater-than sign `>`, vertical bar `|`, colon `:`, asterisk `*`, question mark `?`, backslash `\`, forward slash `/`, character `\0` and a number of other function characters.
 - The virtual file system imposes a restriction on the same name of files, i.e. two files cannot have the same name.
2. **Type** — type, stores information about whether this resource is a file or a directory.
3. **Id** — an impersonal identifier unique for any file.
4. **ParentId** — parent identifier, based on which the file system is built.

Each file or directory has a parent directory that contains that file or directory. The root directory is an exception, it has no parent and cannot be assigned a parent.

5. **Tags** — a list of tags.

A displayed list of any data for convenient filtering and viewing in the user panel.

6. **Icon** — a file or directory icon, no icon by default.
7. **Size** — the size of a file or directory.

The size of a directory is always 16 KB, and the size of nested directories and files is not automatically calculated. For a file, the minimum size is 16 KB.

8. **SubscriptionId** — the identifier of a subscription or workspace.

Each file or directory must belong to a workspace.

9. **CreatorUserId** — the identifier of the user who created a resource.
10. **EditorUserId** — the identifier of the user who last modified a resource.
11. **CreatedTime** — the date and time a resource was created.

12. `EditedTime` — the date and time a resource was last edited.

User permissions

User permissions for files are divided into 6 groups.

1. `Get` — getting some information about a file or directory.
 1. `Entity` — information about a file or directory as a whole: name, size, icon, etc.
 2. `Count` — the number of child directories and files inside a directory. Not applicable to files.
 3. `Download` — the ability to download a file.
 4. `Permission` — information about user access permissions to a file or directory.
 5. `Thumbnail` — low-resolution preview icon.
2. `Update` — updating information about a file or directory.
 1. `Place` — the ability to transfer a file or directory to another directory.
 2. `Name` — renaming a file or directory.
 3. `Icon` — changing an icon.
 4. `Tags` — editing the list of tags.
3. `Create` — creating or changing any data directly related to a file or directory.
 1. `Entity` — creating new child elements inside the directory.
4. `Delete` — deleting the data directly associated with a file or directory.
 1. `Entity` — deleting a file or directory.
5. `Execute` — launch of applications or tasks to process a file or directory.
 1. `Export` — export of a template or report.
 2. `Prepare` — preparing a report from a template.
 3. `Design` — template design.
6. `Administrate` — administrative access to the rights of a file or directory.
 1. `Owner` — editing the owner of a file or directory and the rights associated with them.
 2. `Group` — editing the rights of user groups.
 3. `Other` — editing the rights of users of the workspace.
 4. `Anon` — editing the rights of anonymous access to a file or directory.

Webdav and network directory connection

Now FastReport Cloud does not support such functionality.

Report template

The report template is a file in `.frx` of the FastReport .NET report generator (`.xml` file with a specific structure).

FastReport Cloud processes the `.frx` and gets meta information from the report.

Properties

In addition to [the main file properties](#) the report template stores `ReportInfo` meta-information.

1. `ReportInfo` — information from `.frx`.
 1. `Author` — the author of the template. Display name
 2. `Created` — date and time when the template was created.
 3. `CreatorVersion` — FastReport .NET version in which the template was created.
 4. `Description` — description of the template.
 5. `Modified` — date and time when the template was last edited.
 6. `Name` — the name of the template.
 7. `Picture` — thumbnail, screenshot, template preview.
 8. `PreviewPictureRatio` — thumbnail scaling factor from 0 to 1.
 9. `SaveMode` — report saving mode, used by FastReport .NET desktop designer.
 10. `SavePreviewPicture` — indicates whether the thumbnail will be saved when saving the report.
 11. `Tag` — any additional information.
 12. `Version` — version of the template.

Creating a new template

There are following ways to create or modify report templates:

1. Using the FastReport Cloud [user panel](#), you can both create and edit templates.
2. Using [the FastReport .NET designer](#).
3. Using the free version of the [FastReport Community](#) designer.

To edit a template on a computer, you will first have to download it, modify it using the designer, and then upload it back to the cloud. In this case, the template will have a different identifier. When editing a report template in [the online designer](#) the template identifier will be saved, so you don't need to update the identifier in your applications.

Building a report

Inside FastReport Cloud, there is a builder based on FastReport .NET Core that allows you to generate reports (`.fpx`) from templates. Building one report cannot exceed 15 minutes (for security reasons).

Also, according to the report template, you can build a report in other formats without saving the prepared report.

User permissions

User permissions are common to all file types. The list is available in the [file storage](#) section.

Report

A report (prepared report) is a file in `.fpx` of the FastReport .NET report generator (`.xml` file with a specific structure).

FastReport Cloud processes the `.fpx` and gets meta information from the report.

Creating a new report

You can create a report:

1. Using the FastReport Cloud [user panel](#) when building a report template.
2. Download a ready `.fpx` file obtained with the FastReport .NET library.

Properties

In addition to [the main file properties](#), the report stores the `ReportInfo` meta-information, the identifier of the template from which a report was built, and the status of a report.

1. `ReportInfo` — information from `.frx`.
 1. `Author` — the author of a report. Display name.
 2. `Created` — date and time when a report was built.
 3. `CreatorVersion` — version of FastReport .NET in which a report was built.
 4. `Description` — description of a report.
 5. `Modified` — date and time when a report was last edited.
 6. `Name` — the name of a report.
 7. `Picture` — thumbnail, screenshot, report preview.
 8. `PreviewPictureRatio` — thumbnail scaling factor from 0 to 1.
 9. `SaveMode` — report saving mode, used by FastReport .NET desktop designer.
 10. `SavePreviewPicture` — indicates whether the thumbnail will be saved when saving a report.
 11. `Tag` — any additional information.
 12. `Version` — version of a report.
2. `TemplateId` — template identifier in FastReport Cloud storage.
3. `Status` — the status of what exactly is happening with the report at the moment. It can have one of the following values:
 - `None` — no information.
 - `InQueue` — in the queue, waiting for its build turn.
 - `InProcess` — the report is running, is at the build stage.
 - `Success` — the report has been successfully built.
 - `Failed` — the build failed.
4. `StatusReason` — indicates the reason for the status (usually for `Failed`), or supplements it.
 - `None` — no information.
 - `AllRight` — nothing interrupted a successful build
 - `Hang` — means that the report was processed too long and was removed from the build.
 - `Error` — there was an error in a report.
 - `NotFound` — the handler did not find the provided file, or the export file was lost.
 - `NotEnoughSpace` — the storage does not have enough free space for a report.
 - `PreparationStarted` — the build has started.
5. `Thumbnail` — low-resolution preview icon.

Report export

Inside FastReport Cloud, there is a builder based on FastReport .NET Core that allows you to export reports (.fpx). For security reasons, the export of one report cannot exceed 15 minutes.

You can find the list of available exports in the [export](#) section.

User permissions

User permissions are common to all file types. The list is available in the [file storage](#) section.

Export

Export (report in export format) is a file obtained in the FastReport .NET report generator. Now it is not possible to upload your files to this repository. The only way a file gets into this storage is when the file is generated as a result of export.

Properties

In addition to [the main properties of files](#), the report export result stores a link to the report from which it was exported, the format that was used during export, and the status—what is currently happening with the file.

- Format** — export format. It can have one of 23 values: Pdf, Html, Mht, Image, Biff8, Csv, Dbf, Json, LaTeX, Odt, Ods, Docx, Pptx, Xlsx, Xps, Ppml, PS, Richtext, Svg, Text, Xaml, Xml, Zpl.
- ReportId** — identifier of the report in the FastReport Cloud storage from which the export result was received.
- Status** — the status of what exactly is happening with the export at the moment. It can have one of the following values:
 - None** — no information.
 - InQueue** — in the queue, waiting for its export turn.
 - InProcess** — the export is at the build stage.
 - Success** — the export has been successfully built.
 - Failed** — the build failed.
- StatusReason** — indicates the reason for the status (usually for **Failed**), or supplements it.
 - None** — no information.
 - AllRight** — nothing interrupted the export process.
 - Hang** — means that the report was processed too long and was removed from the build.
 - Error** — there was an error in the report.
 - NotFound** — the handler did not find the provided file, or the export file was lost.
 - NotEnoughSpace** — the storage does not have enough free space to export.
 - ExportStarted** — export has started.
- Thumbnail** — low-resolution preview icon.

User permissions

User permissions are common to all file types. The list is available in the [file storage](#) section.

Groups

A user group is an association of FastReport Cloud users who have the same access permissions to workspace resources. In other words, these are several users with the same access level, for example, Administrators, Managers, Designers, and Developers.

The workspace does not have groups by default.

Each workspace can have from 0 to N user groups, the total number is regulated by the subscription plan. To add a new user to a group, it must be added to the workspace. This means that a group user is a workspace user and part of the subscription to which the group belongs.

A user can belong to multiple groups.

Properties

The group contains several properties for convenient work.

1. `Id` — a unique impersonal identifier.
2. `Name` — display name, used in the user panel.
3. `Icon` — a group icon.

User permissions

User permissions for groups are divided into 5 categories.

1. `Get` — getting some information about a group.
 1. `Entity` — information about a group: group identifier, display name, etc.
 2. `User` — a list of group users.
 3. `Permission` — information about the user's access permissions to a group.
2. `Update` — updating group properties.
 1. `Name` — changing the name of a group.
3. `Create` — creating or modifying resources directly associated with a group.
 1. `User` — adding a new user to a group.
4. `Delete` — deleting resources directly related to a group.
 1. `Entity` — deleting a group and all connections with users.
 2. `User` — removing a user from a group.
5. `Administrate` — administrative access to group rights.
 1. `Owner` — editing the owner of a group and the rights associated with it.
 2. `Group` — editing the rights of user groups for this group.

This property is used to assign administrators to a group. For example, there is a group called "Designers" and a group called "Administrators". The administrators are listed in the "Administrate" permissions as a group that can edit permissions for the "Designers" group.

3. `Other` — editing the rights of workspace users.

4. Anon — editing the rights of anonymous access to a group.

Data source

A data source (DataSource) is a resource for accessing data. This resource stores a connection string compatible with FastReport .NET library connections.

Each source is tied to a subscription, a subscription has no data sources by default.

Properties

The data source contains the following properties.

1. `Id` — a unique identifier for the data source.
2. `Name` — display name, used solely for the convenience of users.
3. `ConnectionType` — connection type, connector name from the FastReport .NET library, can take one of the following values: `JSON`, `MSSQL`, `CSV`, `XML`, `MySQL`, `PostgreSQL`, `OracleDB`.
4. `ConnectionString` — a connection string compatible with the FastReport .NET library.
5. `DataStructure` — a data structure, a piece of information from a report `.frx` template, used by the online designer. It is generated automatically after creating a new data source.

User permissions

User permissions for sources are divided into 4 categories:

1. `Get` — getting some information about the data source.
 1. `Entity` — information about a data source: data source identifier, display name, etc.
 2. `Permission` — information about the user's access permissions to a data source.
2. `Update` — updating the properties of a data source.
 1. `Name` — changing the name of a data source.
 2. `SubscriptionId` — changing the workspace of a data source.
 3. `DataStructure` — changing the data structure.
 4. `ConnectionString` — changing the connection string.
3. `Delete` — deleting resources directly related to a data source.
 1. `Entity` — deleting a data source.
4. `Administrate` — administrative access to data source rights.
 1. `Owner` — editing the owner of a data source and related rights.
 2. `Group` — editing the rights of user groups.
 3. `Other` — editing the rights of workspace users.
 4. `Anon` — editing the rights of anonymous access to a data source.

Online designer

The online designer is the html5 version of the report designer in [.frx](#), see more on the [FastReport Online Designer](#).

API access key

An access key (API Key) is one of the ways to get access to FastReport Cloud resources, most often used to authorize an application. Each user can request up to 5 access keys.

If the application uses an access key, then all actions in FastReport Cloud will be performed by the user to whom the key was issued.

You can read more about the authentication and authorization processes in the guide section: [Authentication and authorization](#).

Properties

1. **Value** — the key itself, generated automatically, it is unique.
2. **Description** — the description of the key, displayed to the user.
3. **Expired** — time and date when the key will stop working. Expired keys are not automatically deleted.

User permissions

Does not have any permissions, because only the user can access it.

User permissions

User permissions, access permissions — a system for differentiating and managing access to FastReport Cloud resources. Access permissions are differentiated according to subjects-to-objects principle, where the subject is a user, a group of users, other workspace users, anonymous, and the object is the FastReport Cloud resource.

Unique access permissions can be assigned to each resource. However, if they are not specified, the default rights specified in the workspace will be used. You cannot adjust the rights of each resource separately through the user panel, but it can be done via REST or SDK.

Properties

Each FastReport Cloud resource has a user permission model and contains the following data:

1. Owner ID—an impersonal user number.
2. Owner permissions. Please note that the user panel does not allow you to remove the rights for the owner, however, this can be done through REST or SDK (it is highly not recommended to do this, because you can lose access to the workspace).
3. List of groups.
 1. Group identifier.
 2. Permissions for this group.
4. Permissions for workspace users. It affects all users of the workspace, regardless of group. All workspace members have full rights by defaults.
5. Permissions for anonymous users.

Permission properties

Property categories are common for each FastReport Cloud resource.

1. `Get` — getting information about a resource, for example, the name of a file.
2. `Update` — updating any resource properties, for example, the name of a subscription.
3. `Create` — creating or adding any information to a resource. Also, it maybe be adding new resources related to the specified one, for example, creating a subscription group.
4. `Delete` — deleting information directly related to a resource, for example, removing a user from a subscription.
5. `Execute` — launching the execution of a task, for example, report build.
6. `Administrate` — administration of permissions. Having access to these permissions, you can change other permissions, they allow you to fully administer the properties of permissions.

Each category has the `All` permission, which will give all rights to the resource, including those that may be added later.

Sharing Keys

For some types of models (files, for example) a list of sharing keys may be created. Sharing keys are objects with following properties :

1. `Name` - User-created name for a key, to indicate what this key was created for.
2. `Expires` - Date and time, when this key will stop working.
3. `Permissions` - List of permissions, that this key gives, when used.
4. `Key` - The key itself, which must be specified in the query parameters to use it.

To use a sharing key you can set a request's query parameter `accessKey`, equal to sharing key's `Key` value. In that case all permissions, that this key is granting will be given to a user (even anonymous one's) until request resolves.

Check procedure

When a user submits any get request to get, change, or delete a resource associated with a workspace, a permission check takes place. If the resource access permission property is not set, it is taken from the default permissions in the workspace. Also, if the sharing key was specified in the query parameters of a request - all checks for permissions, specified in the key's model will succeed.

Requesting your rights

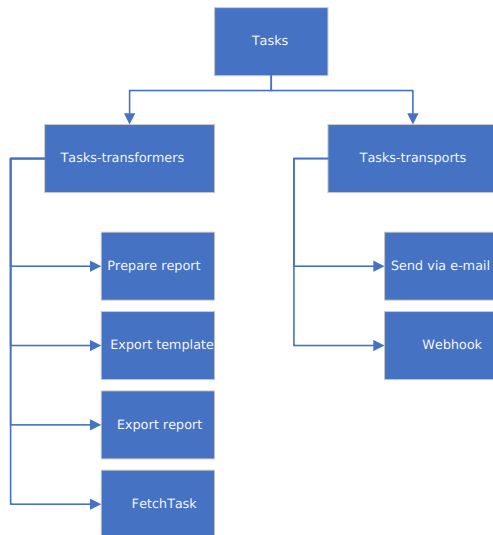
Each user can request their rights to a resource using REST or SDK. The returned model will have an aggregation of all available rights. If the resource is not found or the user does not have rights to the resource, then an empty model will be returned.

Tasks

A task is a unit of work in FastReport Cloud. All transformations, whether it is creating a report from a template, exporting to various formats, or sending a file to the mail, are tasks.

There are the following types of tasks:

- transformer tasks (transformers);
- transport tasks (transports).



Task properties

All tasks have the following properties:

1. `Name` - task name (for example, "Distribution of pay slips to employees");
2. `Locale` - localization that should be used when building a report;
3. `SubscriptionId` - the identifier of the workspace where the task is launched (if not specified, the default workspace for the user running the task will be used).

The remaining properties are unique for each task type.

Transformers

Transformers are designed to transform source objects into final objects through some transformation function.

There are the following transformers:

- report preparation (`PrepareTemplateTask`) - template -> report;

- template export (`ExportTemplateTask`) - template -> a file in the required format (pdf, html);
- report export (`ExportReportTask`) - report -> a file in the required format (pdf, html);
- adding a data structure to a data source (`FetchTask`) - a data source without a structure -> a data source with a data structure that can be used further in the Designer.

The properties of transformers

All transformers, in addition to the main properties of the tasks described above, contain the following properties:

1. `InputFile` - information about the template from which the report should be created; it contains the following fields:
 - `EntityId` - template identifier;
 - `Type` - file type (in this case, the type should be `Template`);
 - `Content` - template content as a byte array (can be passed instead of an identifier);
 - `FileName` - template name (optional).
2. `OutputFile` - information about the report generated by the task (apart from fields similar to the `InputFile` fields, it also contains the `FolderId` field—the folder where the report should be saved. If it is not specified, the report will not be saved);
3. `Transports` - a list of transport tasks called after report preparation.

Thus, the result of each transformer task can be sent using transport tasks (by mail, webhook).

Note that the `Content` field is only available when starting a task from the request body.

If you do not specify `OutputFile`, then it will be saved to a temporary folder (the id of which is the same as the id of the running task), if you specify an empty `OutputFile`—to the root folder, otherwise—to the specified folder.

PrepareTemplateTask

`PrepareTemplateTask` converts a template (.frx file) into a report (.fpx file).

In addition to the general properties of tasks, transformers, it contains the following properties:

1. `PagesCount` - the number of prepared pages (if not specified, a report with all pages will be generated);
2. `ReportParameters` - a dictionary of parameters passed during the build;
3. `Exports` - a list of exports (tasks of the `ExportReportTask` type) called after the report is prepared;

As can be seen from the specified properties, the result of the report preparation task, in addition to its sending by transport, can be additionally exported (and then saved or sent to the recipient in the same way).

ExportReportTask

`ExportReportTask` converts a report file (*.fpx) into a file in the specified format (pdf, html, jpeg, etc.).

In addition to the general properties of tasks, transformers, it contains the following properties:

1. `ExportParameters` - export parameters unique for each export (specified in FastReport .NET documentation);
2. `Format` - export format (pdf, html, svg, and others);

3. `PagesCount` - number of exported pages starting from the first one;

ExportTemplateTask

`ExportTemplateTask` converts a template (*.frx file) into a file in the specified format (pdf, html, jpeg, etc.).

Before exporting, the template is converted into a report, populating the necessary data. Thus, the template export task, in addition to the general task properties, transformers, and report export task properties, contains the `ReportParameters` property, which specifies the report preparation parameters.

Fetch task

This task adds a structure (tables, their column names, and data types) to the data source, which can be used further in the Designer or in the user panel.

Transports

Transports are designed to deliver objects generated by transformers to the final destination, whether it be a group of users, data storage, or another program.

There are the following transports:

- Email (`EmailTask`);
- webhook (`WebhookTask`);

All transports have the following properties:

1. `Files` - a list of files to be sent (templates, reports or exports. The properties of each item are the same as `InputFile` properties of transformers);
2. `Type` - transport task type (`Email`, `Webhook`).

EmailTask

`EmailTask` allows you to deliver the results of transformers to email. It is possible to send templates, reports, and exports both to one recipient and to a group.

In addition to common properties for all transports, it contains the following properties:

1. `Body` - the text of the message;
2. `IsBodyHtml` - format email text as html markup;
3. `Subject` - the subject of the message;
4. `To` - a list of email addresses;
5. `From` - sender's email address;
6. `Username` - email username;
7. `Password` - user password;
8. `Server` - email server smtp address;
9. `Port` - server port;
10. `EnableSsl` - whether ssl encryption is enabled;

Properties 5–10 are optional. The Fast Reports Inc. email server parameters are used by default.

FTPUploadTask

`FTPUploadTask` allows you to deliver the results of transformers to FTP-server. It is possible to send templates, reports, and exports.

In addition to the common properties for all transports, it includes the following specific properties:

1. `FtpHost` - FTP server address;

2. `FtpPort` - FTP server port;
3. `FtpUsername` - FTP server username;
4. `FtpPassword` - password;
5. `DestinationFolder` - path to the folder where the files will be uploaded;
6. `Archive` - whether to archive the file. Accepts the values true or false;
7. `ArchiveName` - archive name;
8. `UseSFTP` - whether to use SFTP (Secure FTP) for the connection. Accepts the values true or false;

Webhook

`WebhookTask` or a custom callback task delivers the results of transformers to a third-party server by making an HTTP POST request at the specified address. It is possible to send templates, reports, and exports.

`WebhookTask`, in addition to the basic ones for all transports, contains the `Endpoints` property, which is a list of objects containing the following fields:

1. `Url` - the address of the server and application to which the POST request from FastReport Cloud comes;
2. `BearerToken` - token if authorization is required.

The data sent to the third-party server is of type `multipart/form-data`, that is, it is a list of files (templates, reports, or exports). The name of the list passed in the request is `files`. The receiving party must implement a method that processes the POST request at the specified address using the resulting list.

For example, for ASP.NET, the Web API function, to which the webhook is assigned, might look like this:

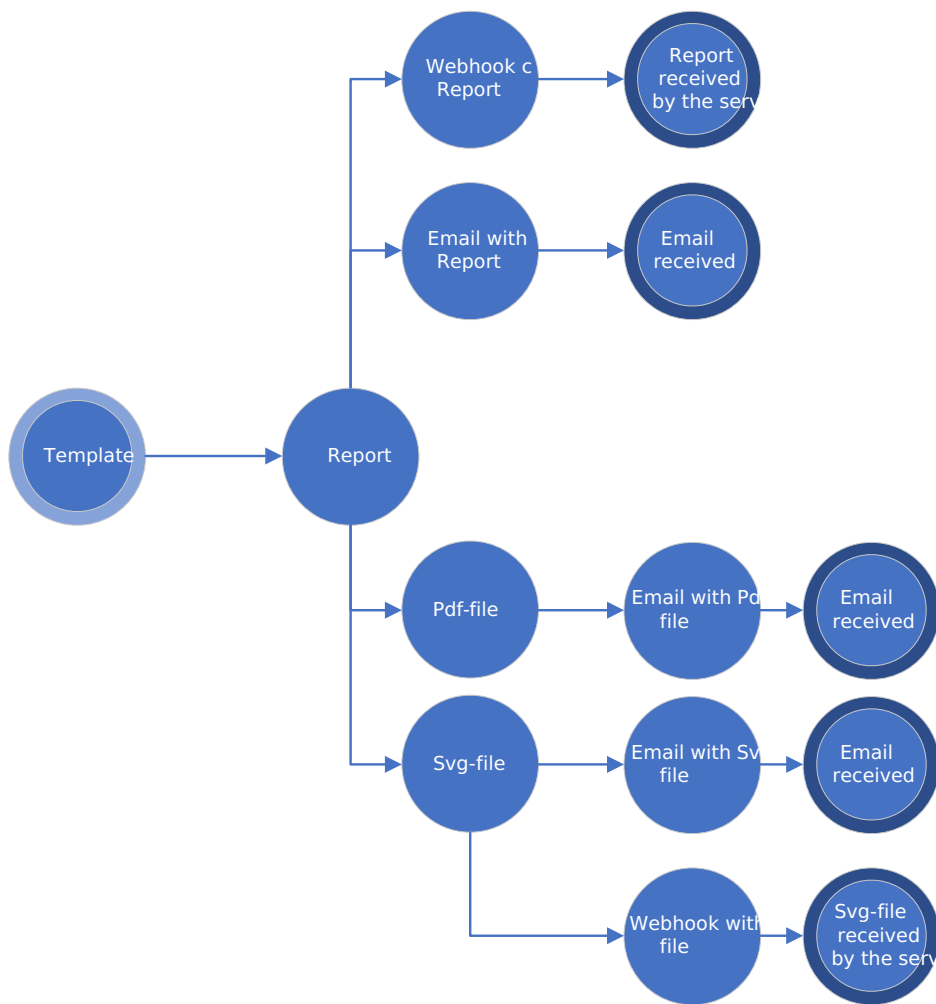
Tree tasks

Tasks can have a tree structure and contain subtasks. For example, *the report preparation task* may contain the following subtasks:

1. List of transports (email, webhook) that send the finished report;
2. List of export tasks (`ExportReportTask`)—export to pdf, html.

Export tasks, in turn, can have a list of transports.

Thus, the sequence of execution of the report preparation task may look like this:



That is, the task of converting from a template to a report, after its execution, will call the PDF export task and SVG export task. And those, in turn, will call email or webhook tasks.

Saving and reuse

Tasks can be saved to cloud storage and run on demand or a schedule (task scheduler feature will be implemented in future builds). You can find examples of how to work with tasks in the Guides section.

Task interactions scenarios

There are 2 work modes:

1. Running a task from the request body;
2. Running a previously saved task.

In the first case, all parameters are determined at the time of sending a request to run a task, in the second case, the task is saved in the cloud storage and called by a unique identifier.

The user panel is a visual interface for interacting with FastReport Cloud.

Groups

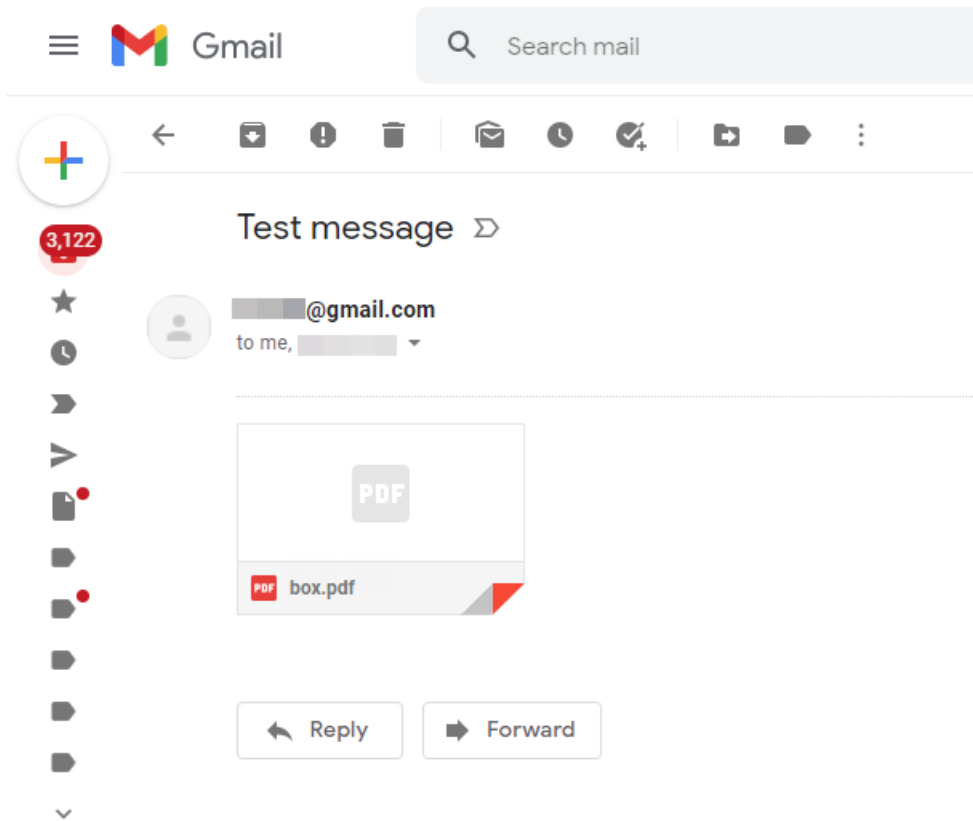
1. Fire-and-Forget—the task starts when the API method is called with its id value.



2. Delayed—starts the task execution at the specified time.
3. Recurrent—starts scheduled tasks using CRON expressions.

Alternative method of uploading files to the cloud

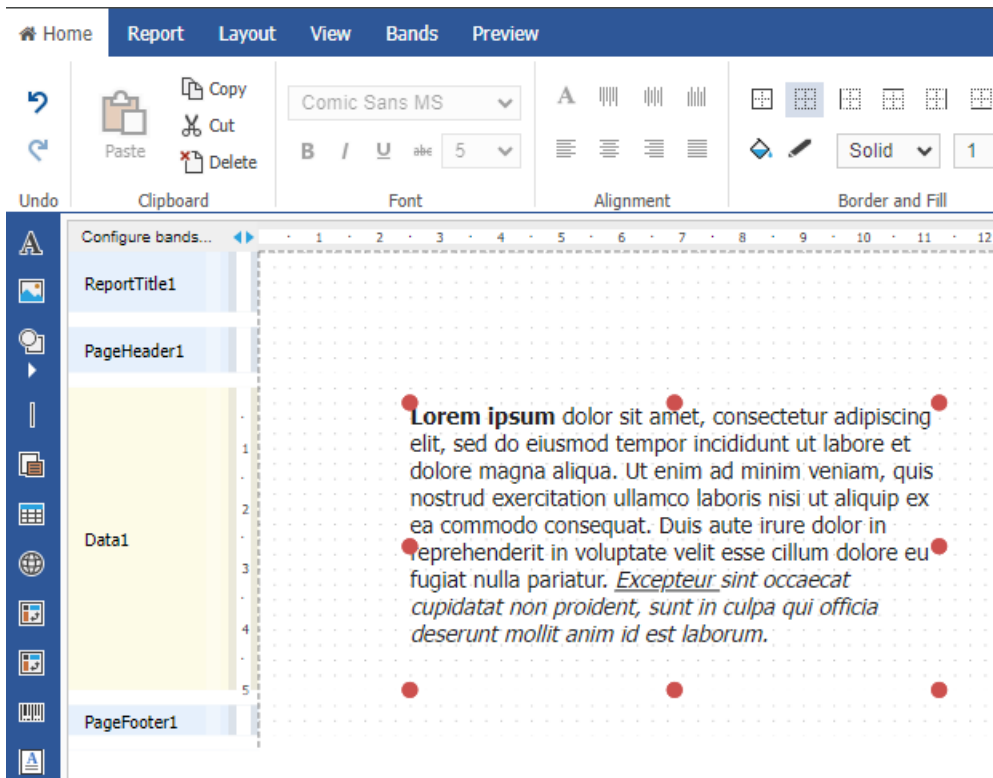
An optimized method for uploading templates (`/api/rp/v2/Templates/Folder/{id}/File`) and reports (`/api/rp/v2/Reports/Folder/{id}/File`) has been added. The new method, unlike the first version, accepts a binary file and thus saves resources. The v1 download methods are marked as obsolete and are not recommended for use.

The method of changing the content of already loaded templates is also updated:

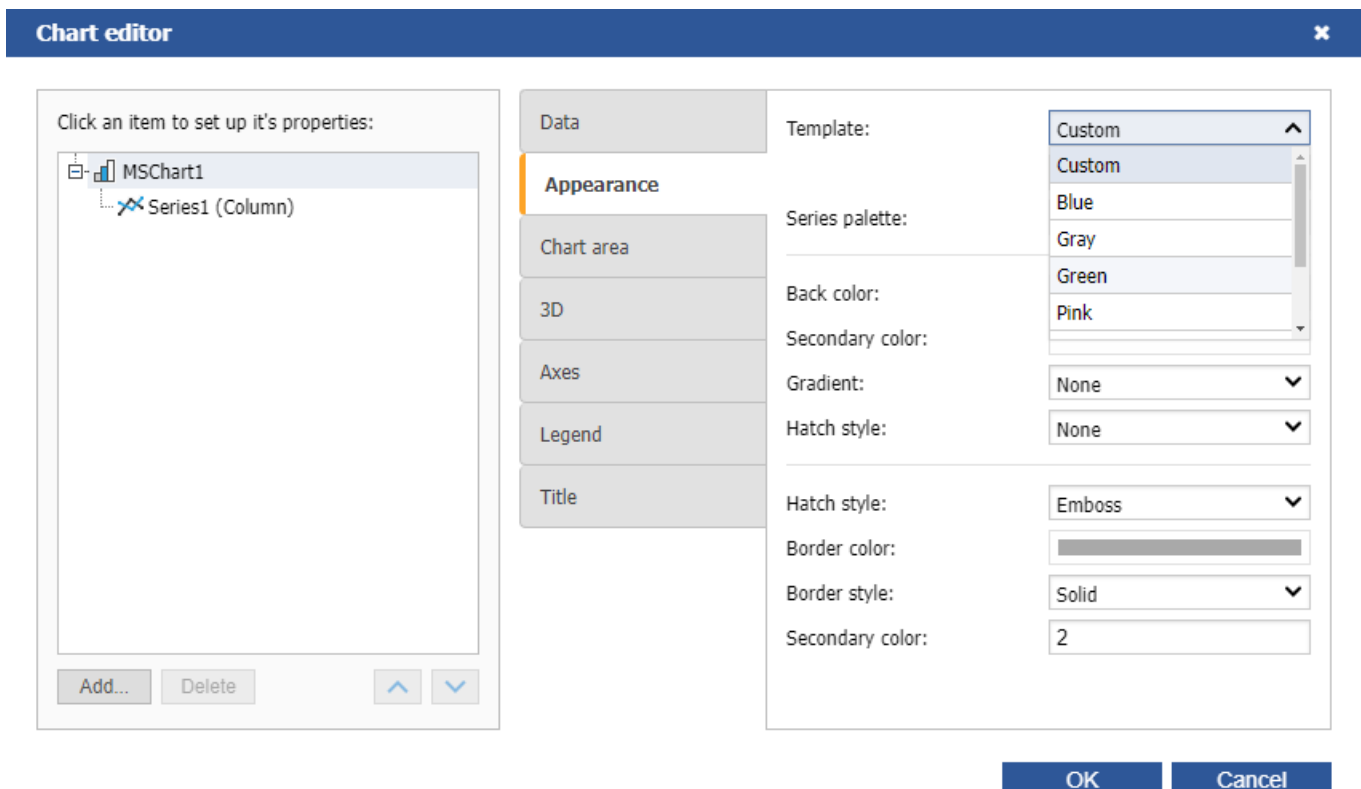
RichText preview in Online Designer

Ability to share via link

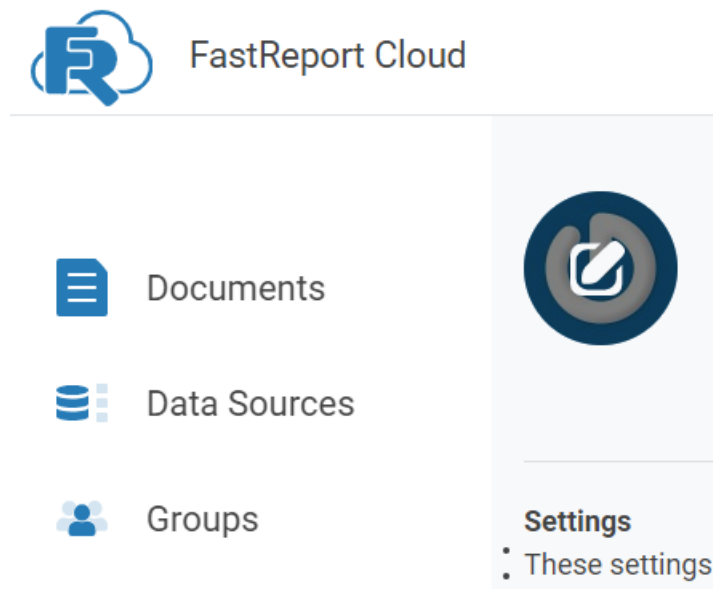
We have added functionality that allows for sharing any files via a link.

Previously, it was possible to open access to the file to any anonymous users. Access can now be restricted with a key added to the link.

To use the access key, it is enough to pass the accessKey parameter, equal to the value of the Key field of the key, with the query. In this case, the user (even an anonymous one) will receive all the rights that this key grants for the time of the query.

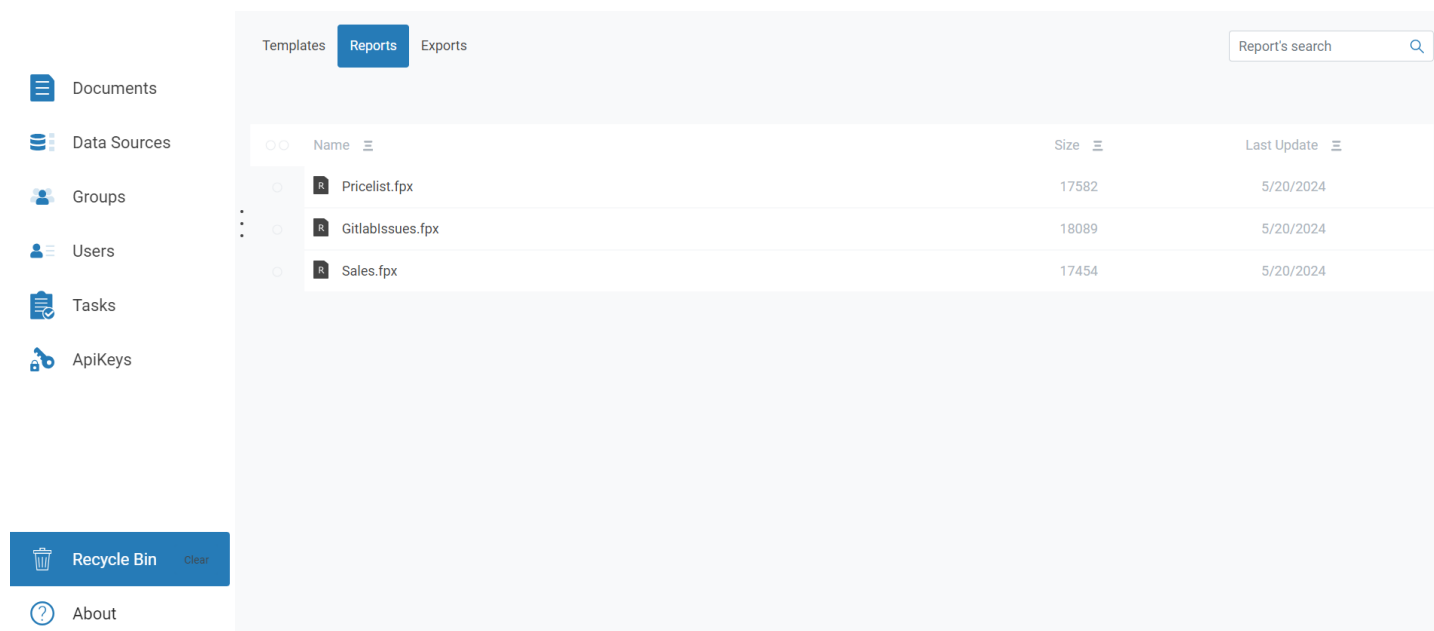
Editing a user's avatar
