

Software License: GigaSoft ProEssentials v10 National

MULTI-USER SOFTWARE LICENSE AGREEMENT BY GIGASOFT, INC.

This is a Multi-User Software License Agreement granted by Gigasoft, Inc. The Software is owned exclusively by Gigasoft, Inc. and remains its intellectual property. It is protected by United States copyright law and international treaty provisions. The Software is provided to the original purchaser and any subsequent owner of the Software media strictly for use under the license terms outlined below.

The term "Licensee" refers to a single organization, including all its employees, contractors, or developers, operating under the organization's control and located within a single nation. This license does not extend to subsidiaries, affiliates, or developers outside the Licensee's resident nation.

Gigasoft grants the original purchaser (hereinafter referred to as "Licensee") limited rights to possess and use the Gigasoft Software and Electronic User Manual solely for its intended purposes. The Licensee may use the ProEssentials v10 software indefinitely, provided the Licensee adheres to these terms and does not violate copyright laws.

The Software may only be used for the Licensee's internal purposes. Licensee is permitted to make up to two (2) backup copies of the licensed software for archival purposes. All backup copies, along with the original, must remain in the Licensee's possession or control. Each backup copy must include all proprietary notices and be clearly labeled to indicate that it is the property of Gigasoft and that its use is subject to this license agreement.

The Licensee may transfer their rights under this License to another party, provided the recipient agrees to the terms and conditions of this License, and Gigasoft is notified in writing. Upon such a transfer, the Licensee must either transfer all copies of the Software to the recipient or destroy them.

The Licensee is strictly prohibited from modifying, decompiling, disassembling, or reverse-engineering the licensed software. Additionally, the Licensee may not rent, lease, or otherwise provide the Software to third parties.

Gigasoft grants the Licensee a non-exclusive, royalty-free right to reproduce and

distribute the files listed above under the following conditions:

The files must be distributed exclusively as part of the Licensee's software application, where ProEssentials adds significant functionality. The software application must not provide presentation charting graphics derived from generic data. The Licensee must include a copyright notice attributing the Licensee's name in the software application product. The Licensee agrees to indemnify, hold harmless, and defend Gigasoft against any claims, lawsuits, or liabilities, including attorney's fees, arising from the use or distribution of the Licensee's software application product. The Licensee may install the Software on an unlimited number of development and test systems and up to twenty (20) production servers. If the files are installed on more than twenty (20) internet or intranet production servers to produce server-based dynamic content, additional runtime licenses are required for additional servers.

The license fees for the Software do not include any considerations for the assumption of risk by Gigasoft. Gigasoft disclaims any and all liability for incidental or consequential damages arising from the use, operation, or inability to use the Software, even if Gigasoft has been advised of the possibility of such damages.

Furthermore, the Licensee agrees to indemnify and hold Gigasoft harmless from any such claims. The entire risk as to the results and performance of the Software is assumed by the Licensee.
