PACE Suite End User License Agreement

This End User License Agreement ("Agreement") is a legal contract between a physical person or legal entity (in either case the "Licensee" or "you"), and LLC "Infopulse Ukraine" ("Infopulse"), a legal entity registered under the laws of Ukraine, for the software named below ("Software").

By clicking on the "I ACCEPT" button or by copying, downloading, accessing, or otherwise using the Software, you agree to be bound by the terms of this Agreement and Licensee represents that you are authorized to enter into this Agreement on behalf of Licensee's corporate entity (if applicable). If you do not wish to be bound by the terms of this Agreement, click the "I DO NOT ACCEPT" button, and/or do not install, access, or use the Software.

1. NON-COMMERCIAL TRIAL LICENSE

Infopulse provides you free of charge with a right to try the Software (including, where applicable, a right to access Subscription Services as defined below) within the limited period of time for evaluation purposes. According to this, you may download or install the Software without purchasing the License to the Software for a fee solely to evaluate the Software suitability for your internal business requirements at your site only.

In any circumstance, you may NOT use the Software in your production activity anyhow, and/or as part of your service for commercial benefit or otherwise commercialize it. Trial License can be issued to one legal entity for a particular Software version only two times. After termination of the second Trial License, you should decide to purchase an appropriate type of License or to delete Software from your servers and/or computers.

2. COMMERCIAL LICENSE TERMS AND CONDITIONS

Subject to the other terms of this Agreement, including without limitation the payment of the applicable License fee, Infopulse grants you a non-exclusive, non-transferable, non-sublicensable license to use the Software as stipulated below.

License Restrictions. In compliance with the License YOU MAY NOT:

- a) assign, sell, sublicense, rent, lease, or distribute the Software (or any portion thereof) some other way to third parties and use the Software (or any portion thereof) for time sharing, hosting or like purposes;
- b) cause or permit reverse engineering, decompile, disassemble, make any attempt to discover the source code of the Software;
- c) modify, translate, or create derivative works from the Software, incorporate the Software (or any portion thereof) into or with other software;
- d) remove any Software identification, proprietary, copyright, or other notices contained in the Software;
- e) disclose the results of any benchmark tests of the Software to any third party;
- f) make more copies of the Software than specified in this Agreement or allowed by applicable law, despite this limitation;
- g) publish the Software or any part of the Software for others to copy;

- h) transfer the Software, any part of the Software or rights provided herein to any third party.

You are entitled only to those rights with respect to the Software as are expressly granted by this Agreement and based on a Type of License you choose.

Your license rights will take effect subject to license fee payment and your acceptance of terms and conditions of this Agreement. No rights are granted for use of illegal copies of the Software, or for legal copies of the Software obtained by unlawful means.

Each user accessing the Software shall be fully aware of License terms and conditions and that he/she is duly authorized by Licensee and has enough knowledge and skills to comply with the License terms and conditions. Licensee shall be fully liable for any omission or breach of the License terms and conditions that may be committed by its users.

3. TYPES OF LICENSES

3.1. PERPETUAL LICENSE

The following type of License is perpetual, this means that Licensee can use the Software with no time limits.

This type of License is based on a single identified user basis what means that the same license may not be used by another unauthorized user, irrespective of whether the authorized identified user is using the Software or not.

This License is per-user which grants the right to install and activate the Software on a single device only.

After the first activation, the License can be transferred two times to other devices automatically, in the unattended mode. Note that some hardware configuration changes may be considered as a License transfer process. All further License transfers to a new device will require contacting PACE Suite Support Team.

The Software components that perform capturing and testing can be run on any number of devices, i.e., computers and virtual machines, with no License activation restrictions.

At the same time, the right to installing the Software for unlimited number of computers and virtual machines inside the legal entity and to running the Software at a third-party environment provided that the Software is used solely by authorized number of users can only be granted by the License purchased before January 1, 2022.

However, if the Software is intended to be exploited by multiple number of users at the same time or is installed on a single computer used by multiple users, your legal entity must purchase Licenses for each user that accesses the Software. Further, if the Software is installed or accessed through a network, your legal entity must purchase additional Licenses for each user that accesses the Software through the network.

3.1.1. MAINTENANCE

The Maintenance provides the right of upgrading to the new versions of Software released within the period of Maintenance duration and access to the Software support services.

After termination, the Maintenance can be prolonged on a fee paid for the next year during 90 calendar days after the date of Maintenance termination. If the Maintenance was not prolonged

during 90 days after its termination date, Licensee loses the right to purchase the Maintenance. Access to PACE Suite Support and Upgrade services can be granted once again after repurchasing the License.

3.2. SUBSCRIPTION LICENSE

Subscription license provides access to Software for a specified period of time. Subscription provides access to the same set of functions as the perpetual Licenses. However, Software stops working next day to the final date of the purchased subscription.

Subscription provides the right of upgrading to the new versions of Software released within the period of Subscription and access to the Software support services.

This type of License is based on a single identified user basis what means that the same license may not be used by another unauthorized user, irrespective of whether the authorized identified user is using the Software or not.

However, if the Software is intended to be exploited by multiple number of users at the same time or is installed on a single computer used by multiple users, your legal entity must purchase Licenses for each user that accesses the Software. Further, if the Software is installed or accessed through a network, your legal entity must purchase additional Licenses for each user that accesses the Software through the network.

3.2.1. SINGLE ENVIRONMENT SUBSCRIPTION LICENSE

This License is per-user which grants the right to install and activate the Software on a single device only.

After the first activation, the License can be transferred two times to other devices automatically, in the unattended mode. Note that some hardware configuration changes may be considered as a License transfer process. All further License transfers to a new device will require contacting PACE Suite Support Team.

The Software components that perform capturing and testing can be run on any number of devices, i.e., computers and virtual machines, with no License activation restrictions.

3.2.2. MULTI-ENVIRONMENT SUBSCRIPTION LICENSE

This License is per-user which grants the right to install and activate the Software on a defined number of devices (environments).

The License can be simultaneously activated on a defined number of devices (environments). Activation of a new device occurs automatically, in the unattended mode, if the number of activated devices (environments) has not reached the maximum limit defined in the License. After reaching this limit, all further activations are considered as a license transfer and will require contacting PACE Suite Support Team. Note that some hardware configuration changes may be considered as an activation of a new device (environment).

The Software components that perform capturing and testing can be run on any number of devices, i.e., computers and virtual machines, with no License activation restrictions.

4. TYPES OF USERS

4.1. "FREELANCER"

This License is for physical persons only and grants the right to an authorized and identified individual to use the Software for private and business purposes.

4.2. "ENTERPRISE"

This type of License can be applied to legal entities only. A single user of the Software must be employed/contracted by the legal entity.

This License grants the right to use the Software **for internal purposes of a business organization purchasing this License only**, excluding any external business purposes providing services to third parties, and make copy of the Software for archival and backup support to reinstall the Software.

4.3. "SERVICE PROVIDER"

This type of License can be applied to legal entities only. A single user of the Software must be employed/contracted by the legal entity.

This type of License grants the right to use the Software **for internal purposes of a business organization purchasing this License, as well as for external business purposes providing services to third parties** and make copy of the Software for archival and backup support to reinstall the Software.

5. PAYMENTS AND DELIVERY

You may pay license and/or subscription fee directly to Infopulse via the official product web site, by means of meeting the invoice or to our authorized License resellers according to their payment conditions. Upon effecting a payment, you will be provided with access code to the Software which you have chosen or to opted subscription. Infopulse does not return the paid License and/or Maintenance fee after the license keys were issued and delivered to the Licensee.

6. PROPRIETARY RIGHTS AND CONFIDENTIALITY

Infopulse or its licensors retain all rights, title and interest to the Software and all related intellectual property and proprietary rights. The Software is protected by applicable copyright, trade secret, industrial and other intellectual property laws. You may not remove any product identification, copyright, trademark, or other notice from the Software. Infopulse reserves any rights not expressly granted to you. "Confidential Information" means all proprietary or confidential information that is disclosed to the recipient ("Recipient") by the discloser ("Discloser"), and includes, among other things (i) any and all information relating to products or services provided by a Discloser, its financial information, software code, flow charts, techniques, specifications, development and marketing plans, strategies, and forecasts; and (ii) as to Infopulse, and its licensors, the Software. Confidential Information does not include information that Recipient can show: (a) was rightfully in Recipient's possession without any obligation of confidentiality before receipt from the Discloser; (b) is or becomes a matter of public knowledge through no fault of Recipient; (c) is rightfully received by Recipient from a third party without violation of a duty of confidentiality; (d) is independently developed by or for Recipient without use of the Confidential Information; or (e) is required to be disclosed by applicable law or court order. The recipient may not disclose Confidential Information of the Discloser to any third party or use the Confidential Information in violation of this Agreement.

You acknowledge that any misuse or threatened misuse of the Software will cause immediately irreparable harm to Infopulse for which there is no adequate remedy at law. Accordingly, you agree that Infopulse IS entitled to immediate and permanent injunctive relief from a court of competent authority in the event of such breach or threatened breach.

7. PRIVACY AND DATA PROTECTION

Infopulse respects and protects your privacy.

The security and confidentiality of your personal information are important to us, and we are committed to protecting the privacy of our customers & subscribers.

Infopulse collects and uses your personal information solely under the current provisions of the applicable data protection legislation.

We collect information that you voluntarily give us solely for the purpose of executing this Agreement.

By clicking on the “I ACCEPT” button or by copying, downloading, accessing, or otherwise using the Software, you agree with the following:

To the extent strictly necessary to provide End User with the Software or Maintenance, Infopulse collects, uses, and otherwise processes End User’s data at Infopulse’s License servers, located in EU, and End User consents to such processing of personal data by Infopulse for the purpose of supporting license rights.

The only categories of personal data we process are:

- 1) Business contact information provided by End-user (Organization name, Licensee full name, post address, telephone, e-mail).
- 2) Technical information provided by the End-user computer system within the software request of the license activation (Computer IP Address, Computer Name, User Name, MAC Address).
- 3) Technical information that is not personal data, like the system time and Hash of the system configuration parameters.

The technical information mentioned above in 2) and 3) is sent by installed Software within the license activation request to the Infopulse License servers.

We inform and the End-user acknowledges and agrees with the software verification function that sends from time-to-time Technical Information mentioned in 2) and 3) to the Infopulse License servers for the license terms support and statistical purposes.

Infopulse confirms that it has implemented a corporate security management system (CSMS) that includes all required security technical and organizational measures to protect the End-user data in a proper and legitimate manner. The CSMS is certified under the ISO 27001.

You are informed of your rights to obtain from Infopulse the information and access to your personal data, to rectify the inaccurate personal data and its erasure free of charge.

Infopulse shall provide the End User with a copy of the personal data undergoing processing by the End-user request if the End-user is positively identified as the personal data subject.

Upon End User's request or expiration of three years following the license termination where your personal data are no longer necessary for the purpose they were collected or otherwise processed, the data shall be erased or restricted of processing unless otherwise required for compliance with Infopulse legal obligation.

Infopulse hereof undertakes to comply with all applicable legal requirements regarding privacy and data protection.

Following the conclusion of this Agreement, Infopulse is entitled to use and store personal data for the performance of this Agreement, including billing purposes, sending Maintenance notifications, and for compliance with a legal obligation, which requires using and storage by law, to which Infopulse is subject.

8. GOVERNING LAW AND ARBITRATION

This Agreement shall be governed by the substantive law of England and Wales, without reference to its provisions on conflict of laws. All disputes arising out of or in connection with this Agreement shall be finally settled under the Rules of Arbitration of the International Chamber of Commerce by three arbitrators appointed in accordance with the said Rules. The seat of the arbitration shall be Paris. The language to be used in the arbitral proceedings shall be English language.

9. WARRANTY

To the extent permitted by applicable law, the Software is provided to you "AS IS" without warranty, either express or implied, that Software usage will be uninterrupted and that all errors have been or can be eliminated from the Software. However, Infopulse warrants to you that for a period of one (1) year the Software shall operate in substantial conformity with the Software documentation. Infopulse's sole liability (and your exclusive remedy) for any breach of this warranty shall be, in Infopulse's sole discretion, to use commercially reasonable efforts to provide you with an error correction or workaround which corrects the reported nonconformity, to provide software upgrades with corrected errors for the upcoming software release or service pack or if Infopulse determines such remedies to be impracticable within a reasonable period of time, to terminate the Agreement and refund license fee paid for the Software. The limited warranty shall not apply to warranty claims arising out of or relating to: (a) use of the Software with hardware or software not required in the Software documentation; (b) to defects in the Software due to accident, abuse, or improper use by you; or (d) to Software provided on a no charge or non-commercial trial use basis.

10. LIMITS ON LIABILITY

INFOPULSE IS NOT LIABLE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES RELATING TO OR ARISING OUT OF THIS AGREEMENT, SUPPORT, THE SOFTWARE (INCLUDING, WITHOUT LIMITATION, LOST PROFITS, LOST COMPUTER USAGE TIME, AND DAMAGE TO, OR LOSS OF USE OF DATA CONSIDERED AS INDIRECT LOSS), EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, WHETHER SUCH DAMAGES RESULT FROM A CLAIM ARISING UNDER TORT OR CONTRACT LAW. EXCEPT IN THE CASE OF INFRINGEMENT, INFOPULSE'S TOTAL LIABILITY FOR DAMAGES OF ANY

KIND IS LIMITED TO THE AMOUNT PAID FOR THE LICENSE TO THE APPLICABLE SOFTWARE GIVING RISE TO SUCH DAMAGES.

11. TERMINATION

Infopulse may terminate this Agreement if (a) you fail to make payment and/or (b) you fail to comply with the terms of this Agreement within fourteen (14) days after receipt of written notice of such failure. Upon any termination of this Agreement or any License, you agree to immediately discontinue any use of the Software, de-install it and destroy the Software and copies of associated databases (if any), and any copies. Upon Infopulse's request, you will provide written certification of such compliance.
