

LEADTOOLS
Registration Certificate for Third Party Developers

This document sets forth the terms and conditions (“Terms”) applicable to consultants and other contracting entities who are developing End User Software on behalf of a LEADTOOLS licensee (“LEADTOOLS Licensee”).

The undersigned person or entity (“Third-Party Developer”) confirms its agreement and compliance with the Terms.

LEADTOOLS Software License Agreement. In addition to the Terms, Third-Party Developer’s use of the LEAD SDK is governed by the LEADTOOLS Software License Agreement (“SLA”) which is accepted upon installation of the LEAD SDK. Capitalized terms not otherwise defined herein will have the meaning ascribed to such terms in the SLA.

Development Deployment License. Third-Party Developer is developing and maintaining End User Software for Deployment by LEADTOOLS Licensee. Third-Party Developer is using a Development License that was purchased by LEADTOOLS Licensee for a designated number of developers to develop the End User Software. Third-Party Developer will not use the LEAD SDK for any purpose other than for developing and maintaining the End User Software for LEADTOOLS Licensee, and will not use the LEAD SDK for other projects or for other customers. Third Party Developer will be eligible for technical support and maintenance services for purposes of developing and maintaining the End User Software for as long as LEADTOOLS Licensee renews its license and support agreements with LEAD.

Deployment Licenses. LEADTOOLS Licensee will be responsible for purchasing and renewing any required Deployment Licenses and support and maintenance in connection with its deployment of the End User Software. If Third-Party Developer needs to deploy the End User Software on its own hardware for non-production purposes, it will inform LEADTOOLS Licensee of its requirements and LEADTOOLS Licensee will be responsible for purchasing the necessary Deployment Licenses.

License Termination. In the event LEADTOOLS Licensee’s Deployment Licenses are not renewed, the Development License used by Third-Party Developer will terminate and Third-Party Developer will be required to uninstall and remove the LEAD SDK from all computers and cease further development with and use of the LEAD SDK.
