LEADTOOLS

Registration Certificate for Consultants and Systems Integrators

This document sets forth the terms and conditions ("Terms") applicable to consultants, systems integrators and other contracting entities who are LEADTOOLS licensees and are developing End User Software on behalf of a third-party end user customer ("End User") as a work for hire.

The undersigned entity ("Licensee") confirms its agreement and compliance with the Terms.

<u>LEADTOOLS Software License Agreement.</u> Licensee's use of the LEAD SDK is governed by the LEADTOOLS Software License Agreement ("SLA") which is accepted by Licensee upon installation of the LEAD SDK. Capitalized terms not otherwise defined herein will have the meaning ascribed to such terms in the SLA.

<u>Deployment Licenses and Compliance</u>. Licensee is developing and maintaining End User Software for Internal Deployment by End User. Licensee is responsible for purchasing and renewing Internal Deployment Licenses on behalf of End User. Licensee's contract with End User ensures that End User will account to Licensee for the number and type of Deployments of End User Software by End User and will otherwise ensure Licensee's compliance with the SLA and these Terms.

<u>License Assignment</u>. Licensee's Development License may be transferred and assigned to End User by written assignment in form acceptable to LEAD and signed by both Licensee and End User, whereupon Licensee's license to use the LEAD SDK will terminate and End User will assume all SLA obligations arising subsequent to the assignment.

Source Code to End User Software. Licensee will not provide the source code to the End User Software or the LEAD SDK to End User unless and until (i) a valid assignment has been executed by Licensee and End User; or (ii) End User obtains its own LEAD SDK Development License for use in connection with the End User Software.

<u>License Termination</u>. In the event annual Internal Deployment Licenses are not renewed, Licensee is responsible for terminating End User's rights to use the End User Software and will take reasonable measures to confirm that the End User Software has been removed from End User's facilities or otherwise deactivated to prevent continued use.
