## Types of Licenses

### 1. Standard Edition

This license type is available to download from Master Packager’s website at any time by anyone without registration. Standard Edition is free and includes basic MSI Editing functions of Master Packager software to enable user to perform common packaging and MSI editing tasks. Detailed function list for Standard Edition can be found in Master Packager’s website.

## 2. Professional Edition

This paid license type is available to download from Master Packager's website. This license type includes full Master Packager software functions. This version includes Master Repackager software, that allows to capture system changes and place them into MSI file. Detailed Professional Edition license function list can be found in Master Packager's website.

License is per-user.

A licensed user can install Software on unlimited machines, however, a licensed user is the only one who is allowed to use the software. Master Packager Professional Edition license must be used to activate the software and can be activated while being offline as well allows you to use software without an internet connection. License for purchased major version does not have an expiration date and may be used indefinitely.

## 3. Trial License

To evaluate the Software suitability for your requirements we provide 30-day trial per-user license for Professional Edition. This license type is available to download from Master Packager's website. You may download and install the Software without purchasing the License. In any circumstance, you canNOT use the Software in your production environment anyhow, and/or as part of your service for commercial benefit or otherwise commercialize it.

License is per-user.

A licensed user can install Software on unlimited machines, however, a licensed user is the only one who is allowed to use the software.

## Payment and license delivery

Master Packager Professional Edition license is paid product and must be purchased from Master Packager website.

There are two payment methods available:

### \* Invoice
