Introduction

Thank you for choosing Master Packager software ("Master Packager", "we", "us", "our"). By signing up or otherwise using the Master Packager services and Master Packager application available for Windows Operating system ("Software") or accessing any content or material that is made available by Master Packager through the software or website ("Content"), the User("you", "yours") is entering into a binding contract with the Master Packager entity indicated in this document.

Your agreement with us includes Terms and Conditions of Use ("Terms") and our Privacy Policy. The Terms, Privacy Policy, and any additional terms that you agree to, as discussed in the Privacy and End-User License Agreement, are referred to together as "Agreements". If you wish to review the Agreements, find their effective version on the Master Packager website. You acknowledge that you have read and understood the Agreements, accept these Agreements, and agree to be bound by them. If you don't agree or cannot comply with the Agreements, then you may not use the Master Packager or consume any Content.

Changes to the Agreements

Ownership

Master Packager and its source code are proprietary products of Master Packager Ltd. and are protected by copyright and other intellectual property laws. Master Packager Software is licensed and not sold. You acquire only the right to use the Software and do not acquire any rights, expressed or implied, in the Software other than those specified in this Agreement.

Types of licenses

1. Community

This license type is available to download from the Master Packager website at any time by anyone without registration. The Community is free of charge for everyone (including companies and application packaging service providers) and includes the Microsoft Installer (MSI) basic editing functions of Master Packager software to enable Users to perform the most common packaging and MSI editing tasks.

2. Professional

This license type is available when purchased from the Master Packager website at any time by anyone by registration and making the payment. The Professional license includes full Master Packager software functionality designed to package applications of any complexity.

The Professional license is per User.

A User with a license can install Software on an unlimited number of machines, however, a licensed User is the only one who is allowed to use the Software. Example: If you have 4 packagers who will use Master Packager Software, you need to purchase 4 different licenses.

The Master Packager Professional license must be used to activate the Software, and this can be done both online and offline as no internet connection is required for this license type. License for purchased version and versions released during support and maintenance period does not have an expiration date and may be used indefinitely.

Each license comes with 1 year of support and maintenance. This will allow getting the latest Master Packager Software updates and have first priority support by emailing us at <u>info@masterpackager.com</u> when dealing with Software issues.

3. Trial license

To evaluate the Software suitability for your requirements, we provide a 30-day trial per User for the Professional license. This license type is available to download from the Master Packager website. You may download and install the Software without purchasing the license. Under no circumstances, can you use the Software in your production environment in any way, and/or as a part of your service for commercial benefit, or otherwise commercialize it under the Trial license.

The Trial license is per User.

A licensed User can install Software on an unlimited number of devices, however, a licensed User is the only one who is allowed to use the Software.

The Master Packager Trial license can be only be activated and used online as it requires you to have an internet connection to use this Software.

Payment and license delivery

The Master Packager Professional license is a paid product and must be purchased from the Master Packager website.

There are two payment methods available:

1. Invoice

By choosing the invoice payment method you will receive an advance invoice to be paid prior license assigning. After the advance invoice is paid and we have received the payment, we will assign a license during the next 24 business hours. You will receive a confirmation email with a tax invoice attached to the email.

2. PayPal

By choosing the PayPal payment method you'll be able to pay using a PayPal account or credit card. After the payment is done, license(s) will be automatically assigned to you.

All license costs are indicated on the invoice and must be paid with all applicable taxes included.

All Invoices and purchased licenses are available under your Master Packager website account at any time.

Support

With a purchased Master Packager Professional license, you will have rights to receive Master Packager 1-year maintenance that includes all the relevant updates with bug fixes, improvements and new features, as well as access to contact us for any questions related to the Master Packager Software.

Restrictions

The following restrictions are not permitted for any reasons whatsoever.

The Software is licensed, not sold. This agreement gives you limited rights to use the Software only. Master Packager Ltd. reserves all other rights. Unless an applicable law gives you more rights despite this Agreement, you may use the Software only as expressly permitted in this Agreement.
