2.1 Demo version

NEVON LLC DOES NOT PERMIT THE DISTRIBUTION OF APPLICATIONS COMPILED WITH THE EVALUATION VERSION OF THE PROGRAM EXCEPT FOR DEMO AND OTHER NON COMMERCIAL PURPOSES. YOU ARE FREE TO USE THE DEMO VERSION OF THE PROGRAM FOR SUCH PURPOSES FOR AN UNLIMITED PERIOD OF TIME.

2.1 Licensed (retail) version

THE LICENSED (RETAIL) COMPONENTS IN THE PACKAGE ARE ROYALTY FREE FOR USE IN COMPILED APPLICATIONS ONLY. THAT MEANS THAT YOU MAY DISTRIBUTE YOUR PROGRAMS COMPILED WITH NEVRON LLC COMPONENTS INCURRING NO ROYALTY FEE, REGARDLESS OF THE NUMBER OF COPIES YOU REDISTRIBUTE OR THE PRICE OF YOUR PROGRAM. YOU MAY NOT DISTRIBUTE NEVRON COMPONENTS IN ORDER TO USE THEM IN DEVELOPMENT ENVIRONMENTS OR TOOLS DEVELOPED BY YOU (LIKE VB, VC++ ETC.). IF YOU USE NEVRON LLC COMPONENTS IN SUCH APPLICATIONS THE

THE SITE LICENSE GRANTS YOU TO USE THE COMPONENTS ON AN UNLIMITED NUMBER OF COMMERCIAL WEB SERVERS.

NO ADDITIONAL LICENSES ARE REQUIRED FOR TEST SERVERS OR INTRANET SERVERS. THERE IS ALSO NO RESTRICTION ON THE NUMBER OF CPU UNITS IN THE WEB SERVER.
