END-USER LICENSE AGREEMENT

Version 1.5, effective as of april 07, 2025

This version supersedes Version 1.4, effective as of February 26, 2025.

IMPORTANT — READ CAREFULLY: This Optimajet Limited (“OPTIMAJET”) End-User License Agreement (“EULA”) is a legal agreement between you, a developer of software applications, (“Developer End User”) and OPTIMAJET for all OPTIMAJET products, frameworks, components, source code, demos, intermediate files, media, printed materials, and online or electronic documentation (“SOFTWARE DEVELOPMENT PRODUCT(S)”) contained in this distribution.

By installing, copying, or otherwise using the SOFTWARE DEVELOPMENT PRODUCT(S), you agree to be bound by the terms of this EULA. If you do not agree to any part of the terms of this EULA, DO NOT INSTALL, COPY, USE, EVALUATE, OR REPLICATE IN ANY MANNER, ANY PART, FILE OR PORTION OF THE SOFTWARE DEVELOPMENT PRODUCT(S).

All SOFTWARE DEVELOPMENT PRODUCT(S) is licensed, not sold.

1. GRANT OF LICENSE

Subject to all the terms and conditions of this EULA, OPTIMAJET grants Developer End User a non-exclusive, non-transferable license to install and use the SOFTWARE DEVELOPMENT PRODUCT(S) included in this distribution.

2. LIMITATIONS ON REVERSE ENGINEERING, DECOMPILE, AND DISASSEMBLY

You may not reverse engineer, decompile, create derivative works or disassemble the SOFTWARE DEVELOPMENT PRODUCT(S). If the SOFTWARE DEVELOPMENT PRODUCT(S) is purchased by you with the intent to reverse engineer, decompile, create derivative works, or the exploitation and unauthorized transfer of any OPTIMAJET intellectual property and trade secrets, to include any exposed methods or source code where provided, no licensed right of use shall exist and any PRODUCT(s) created as a result shall be judged illegal by definition. Any sale or resale of intellectual property or created derivatives so obtained will be prosecuted to the fullest extent of all local, federal and international law.

3. SEPARATION OF COMPONENTS

The SOFTWARE DEVELOPMENT PRODUCT(S) is licensed as a single PRODUCT(s). The SOFTWARE DEVELOPMENT PRODUCT(S) and its

constituent parts and any provided redistributables may not be reverse engineered, decompiled, disassembled or separated for use on more than one computer, nor placed for distribution, sale, or resale as individual creations by Developer End User. The provision of source code, if included with the SOFTWARE DEVELOPMENT PRODUCT(S), does not constitute transfer of any legal rights to such code, and resale or distribution of all or any portion of all source code and intellectual property will be prosecuted to the fullest extent of all applicable local, federal and international laws. All OPTIMAJET libraries, source code, redistributables and other files remain OPTIMAJET's exclusive property. You may not distribute any files, except those that OPTIMAJET has expressly designated as Redistributable.

4. RENTAL

You may not rent, lease, or lend the SOFTWARE DEVELOPMENT PRODUCT(S).

5. TRANSFER

You may NOT permanently or temporarily transfer ANY of your rights under this EULA to any individual or business or government entity without prior written approval from OPTIMAJET. Regardless of any modifications which you make and regardless of how you might compile, link, and/or package your programs, under no circumstances may the libraries, Redistributables, and/or files included in the SOFTWARE DEVELOPMENT PRODUCT(S) (including any portions thereof) be used for developing programs by anyone other than you. Only you as the licensed Developer End User have the right to use the libraries, redistributables, or other files of the SOFTWARE DEVELOPMENT PRODUCT(S) (or any portions thereof) for developing programs created with the SOFTWARE DEVELOPMENT PRODUCT(S). You may not share copies of the Redistributables with other co-developers. You may not reproduce or distribute any OPTIMAJET documentation without the permission of OPTIMAJET.

6. REDISTRIBUTION

The SOFTWARE DEVELOPMENT PRODUCT(s) may include certain files ("REDISTRIBUTABLE(s)") intended for distribution by you to the users of software applications which you create. Distribution by the Developer End User of any design-time tools, executables, and source code distributed to Developer End User by OPTIMAJET as part of this SOFTWARE DEVELOPMENT PRODUCT(S) and not explicitly identified as a redistributable file is strictly prohibited. The Developer End User shall not develop software applications that provide an application programming interface to the SOFTWARE DEVELOPMENT PRODUCT(S) or the SOFTWARE DEVELOPMENT PRODUCT(S) as modified.

The Developer End User may NOT distribute the SOFTWARE DEVELOPMENT PRODUCT(S), in any format, to others for development or application compilation purposes.

No redistribution allowed for trial versions of this distribution.

Developer End User MAY NOT REDISTRIBUTE any files in the SOFTWARE DEVELOPMENT PRODUCT(S) distribution if using an evaluation, trial, Not for Resale, or demo version of the SOFTWARE DEVELOPMENT PRODUCT(S).

The Licensee may use its own descriptions of the functionality provided by the Licensed Software for the purpose of marketing its products, solutions, or applications, including the Licensee's Products, if applicable, provided that such descriptions are not misleading.

The Licensee agrees not to take any actions that may distort information regarding ownership rights to the Software. The Licensee undertakes not to claim or create the impression that the Licensee owns the copyright to the Software.

You, as Developer End User, must agree not to export or re-export the SOFTWARE DEVELOPMENT PRODUCT(S) within any created application to any country, person, entity or end user subject to Russian Federation.

15. TERMINATION

Without prejudice to any other rights or remedies, OPTIMAJET will terminate this EULA upon your failure to comply with all the terms and conditions of this

EULA. In such events, Developer End User must destroy all copies of the SOFTWARE DEVELOPMENT PRODUCT(S) and all of its component parts including any related documentation, and must remove ANY and ALL use of OPTIMAJET intellectual property from any applications distributed by Developer End User, whether in native, altered or compiled states.

16. MISCELLANEOUS

This EULA may only be modified in writing signed by you and an authorized officer of Optimajet Limited. If any provision of this EULA is found void or unenforceable, the remainder will remain valid and enforceable according to its terms. If any remedy provided is determined to have failed for its essential purpose, all limitations of liability and exclusions of damages set forth in the Limited Warranty shall remain in effect.

17. USAGE TYPES FOR PRODUCT LICENSING

17.1. Non-Commercial Use

Non-commercial use refers to the use of the Software exclusively for personal, educational, scientific, or research purposes, without obtaining any direct or indirect financial gain. This use excludes sharing, developing, distributing, or providing services based on the Software to third parties, as well as any commercial activities associated with the Software.

17.1.2. Examples of Non-Commercial Use:

Personal Projects: Using the Software to develop and test personal projects that are not related to any commercial activities.

Academic and Research Purposes: Using the Software as part of educational programs, scientific research, or academic projects, with no intention of generating commercial profit.

17.1.3. Conditions for Transition to a Commercial License:

If the Software is used for the development, testing, or preparation for the release of a commercial product or service—even in a testing environment—such use is considered commercial and requires the purchase of a commercial license.

Any use of the Software that impacts the organization's revenue or is intended to support the commercial launch of a product or service is automatically classified as commercial.

17.1.4. Additional Clarification:

The use of the Software within internal commercial processes, or for the development, testing, or preparation for the release of products and services intended for commercial sale or monetization, does not qualify as non-commercial use—even if such deployment occurs outside of a production environment (e.g., in testing or demonstration settings).

17.2. Internal Commercial Use

Internal commercial use refers to a type of license granted by Optimajet Limited, which gives the Licensee the right to use the Licensed Software on internal websites and in internal applications within the company's security perimeter.

17.3. Public Web Application / SaaS

This refers to a type of license granted by Optimajet Limited, which gives the Licensee the right to use the Licensed Software in one (1) SaaS application or one (1) web application. A SaaS application refers to a software solution or application provided by the Licensee as a service (i.e., not as a product). Such an application is made available by the Licensee to any number of third parties from a server located outside the company's security perimeter. It may be distributed as a web, desktop, or mobile application and may exist in different versions for various platforms (e.g., iOS and Android versions of a mobile app), provided that such a software solution, application, or product has been approved by Optimajet Limited as a SaaS application through explicit specification in the License Statement.

17.4. OEM Use

OEM use refers to a type of license granted by Optimajet Limited, which gives the Licensee the right to use the Licensed Software as an integral part of the Licensee's product that will be provided to third parties.
