

END-USER LICENSE AGREEMENT FOR OzCode

IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL.

CodeValue LTD End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and CodeValue LTD for the CodeValue LTD software product(s) identified above, which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and CodeValue LTD, (referred to as "LICENSER"), and it supersedes any prior proposal, representation, or understanding between the parties.
