GRANT OF LICENSE

1. Installation and Use

Upon your acceptance of this software license agreement Smart Packer Solutions grants you a non-exclusive, non-transferable, limited license to install and use a copy of the software on your computer, up to the permitted number of computers. As between you and Smart Packer Solutions, files, applications, generated program code that are authored or created by you via your utilization of the Software, in accordance with the terms of this software license agreement, are your property.

2. Full version

In order to use the SOFTWARE for your commercial purposes, you must buy and register the SOFTWARE product via the official website or official partners.

Registration of Smart Packer products gives you the following non-exclusive rights:

- to download the full version of the SOFTWARE,
- to install and use the SOFTWARE for your commercial purposes,
- to download free updates from our web-site,
- to receive information about software updates via e-mail.

When you purchase your copy of the SOFTWARE, you'll receive a download link for the full version and a personal registration code via e-mail you provided.

3. Trial

The trial version of the SOFTWARE is intended solely for evaluation purposes. You can download a demo version of the SOFTWARE from the official web site and install it. Software applications processed with the trial version show a warning screen on startup/exit and are not allowed for distribution.

4. License types

Single developer license is assigned for installation and execution on one computer assembled as a solitary system units and by one user only. If you have an upgrade to this Software, it constitutes a single product together with the product that you upgraded, and may not be used to increase the total number of licensed installations of the Software. Group programming projects making use of this software must purchase a copy of the software for each member of the group or purchase a Site Developer License. Site Developer License is assigned for installation and execution on unlimited numbers of computers by any user inside one building of organization located in one city. Any possible delivery of the product or its parts as well as registration codes or access codes you received with purchasing and/or registering this Software to any individual or organization is strictly prohibited.

A group of project developers who use this software must purchase the Single License for each member of the group or they can purchase the Site License.
