

## ELECTRONIC END USER LICENSE AGREEMENT

FOR Softek Barcode Reader for Multi-Platform Barcode Reader Toolkit for .Net Standard on Docker Distribution License, including one developer license ("License")

### NOTICE TO USER:

THIS IS A CONTRACT, BY INSTALLING AND USING THIS SOFTWARE YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT.

This Softek Software Ltd ("Softek Software") End User License Agreement accompanies the Softek Barcode Reader for Multi-Platform Barcode Reader Toolkit for .Net Standard on Docker product and related explanatory materials ("Software"). The term Software" also shall include any upgrades, modified versions or updates of the Software licensed to you by Softek Software. Please read this Agreement carefully. If you decline this agreement, you will not be able to use the Software.

"Docker" is a set of platform as a service (PaaS) products that use OS-level virtualization to deliver software in packages called containers.

".NET Standard" is a formal specification of .NET APIs that are available on multiple .NET implementations.

"Developer" is defined as a person who develops computer software on Linux, which makes calls to, or is compiled with the Software.

Upon your acceptance of this Agreement, Softek Software grants to you a non-exclusive license to use the Software, provided that you agree to the following:

#### 1. Use of the Software.

The Software may be used in an unlimited number of Docker containers using .Net Standard. This license also entitles you to one Developer. You may also make backup copies of the Software. This license permits the general distribution of software or applications containing the SDK. Use of the software is dependent on continued payment of the annual subscription.

#### 2. Copyright and Trademark Rights.

The Software is owned by Softek Software and its suppliers, and its structure, organisation and code are the valuable trade secrets of Softek Software and its suppliers. The Software also is protected by United Kingdom Copyright Law and International Treaty provisions. You may use trademarks only insofar as required to comply with Section 1 of this Agreement and to identify printed output produced by the Software, in accordance with accepted trademark practice, including identification of trademark owner's name, Such use of any trademark does not give you any rights of ownership in that trademark. Except as stated above, this Agreement does not grant you any intellectual property rights in the Software.

#### 3. Restrictions.

You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Software. You may not alter or modify the installer program or create a new installer for the Software. The Software is licensed and distributed by Softek Software for recognition of bar codes.
