

VaxVoIP Software Development Kit License Agreement This License Agreement defines the terms and conditions under which you (the Licensee) are permitted by VaxVoIP.com (the Licensors) to use the VaxVoIP Software Development Kit.

1. DEFINITIONS

2.1 Licensors hereby grants to Licensee, and Licensee hereby accepts, subject to the terms and conditions set forth in this Agreement, a non-exclusive license to use Software Development Kit as set forth in this Agreement. The term "license" as used in this Agreement shall mean and include:

1.2 "Application Program" shall mean and include one or more software programs created by the Licensee which use the VaxVoIP Software components.

2. LICENSE GRANT

2.1 Licensors hereby grants to Licensee, and Licensee hereby accepts, subject to the terms and conditions of this Agreement, a non-exclusive license to use the VaxVoIP Development Kit ("SDK") as set forth herein. The term "license," as used in this Agreement, shall mean and include:

3. RESTRICTIONS

3.1 In accepting the license granted by Licensors, the Licensee agrees that it shall not:

3.1.1 Include the Redistributable Software in any product that functions as a software development kit, software component, or software library;

3.1.2 Develop a stand-alone, customizable software product using the SDK and resell it as a general-purpose tool;

3.1.3 Permit end-users to redistribute the Redistributable Software in any form;

3.1.4 Loan, rent, lease, sublicense, or sell the Software Development Kit to any third party;

3.1.5 Attempt to decompile, disassemble, or reverse-engineer any portion of the Software Development Kit;

3.1.6 Disclose, share, or transfer the license key received from VaxVoIP to any unauthorized user or third party.

4. TERM OF AGREEMENT

4.1 The term of this Agreement shall commence upon the Licensee's receipt of the Software Development Kit and shall continue in effect indefinitely, unless terminated as set forth in Section 5 (Termination of Agreement).

5. TERMINATION OF AGREEMENT

5.1 The Licensee may terminate this Agreement at any time by destroying all copies of the Software Development Kit in its possession.

5.2 In the event of a material breach of this Agreement by the Licensee, or by any agent or representative of the Licensee, the Licenser may terminate this Agreement upon thirty (30) days' written notice. The Licensee shall have thirty (30) days from receipt of such notice to cure the breach.

5.3 Upon termination of this Agreement, the Licensee shall promptly destroy or return to the Licenser all licensed copies of the Software Development Kit, including all backups. This obligation shall survive termination of this Agreement.

6. COPYRIGHT AND PROPRIETARY INFORMATION

6.1 The Licensee acknowledges that the Software Development Kit and all supporting documentation are valuable property of the Licenser, and that all title, ownership rights, and intellectual property rights therein remain exclusively with the Licenser.

6.2 The Licenser reserves all rights with respect to the Software Development Kit under applicable intellectual property laws, including but not limited to rights in trade secrets, copyrights, trademarks, and patents.

6.3 Except as expressly provided in this Agreement, the Licensee shall not cause or permit the unauthorized copying, reproduction, distribution, or disclosure of any portion of the Software Development Kit or supporting documentation to any third party, for any purpose whatsoever, without the prior written consent of the Licenser. These obligations shall survive termination of this Agreement.

7. INDEMNIFICATION

7.1 The Licensee shall indemnify, defend, and hold harmless the Licenser from and against any and all claims, damages, liabilities, and expenses, including claims by third parties or employees of the Licensee, arising directly or indirectly out of the Licensee's use or operation of the Software Development Kit or Redistributable Software.

7.2 The Licenser shall indemnify and hold the Licensee harmless from loss, damage, or liability arising from direct infringement of any United States, Canadian, or European Union member state patent or copyright with respect to the Software Development Kit or Redistributable Software, provided that:

The Software Development Kit or Redistributable Software has not been modified;

The Licensee promptly notifies the Licenser in writing of any alleged infringement;

The Licensee permits the Licenser to defend, compromise, or settle such claims; and

The Licensee provides the Licenser with all reasonably available information, assistance, and authority necessary for such defense.

7.3 In the event that the use of the Software Development Kit or Redistributable Software is enjoined, or the Licensor otherwise determines it necessary to minimize liability, the Licensor may, at its sole option and expense:

7.3.1 Procure for the Licensee the right to continue using the Software Development Kit or Redistributable Software; or

7.3.2 Replace the Software Development Kit or Redistributable Software with a non-infringing equivalent; or

7.3.3 Modify the Software Development Kit or Redistributable Software so that it becomes non-infringing; or

7.3.4 Refund to the Licensee the purchase price paid, if any, for the Software Development Kit.

8. DISCLAIMER OF WARRANTY

THIS SOFTWARE DEVELOPMENT KIT IS PROVIDED "AS IS" WITHOUT ANY WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT.

BECAUSE OF THE VARIETY OF CONDITIONS AND HARDWARE UNDER WHICH THE SOFTWARE DEVELOPMENT KIT MAY BE USED, NO WARRANTY IS MADE REGARDING ITS PERFORMANCE OR SUITABILITY FOR ANY SPECIFIC PURPOSE. THE LICENSEE IS SOLELY RESPONSIBLE FOR TESTING THE SOFTWARE DEVELOPMENT KIT BEFORE RELYING ON IT.
