Definitions

- * Visual Integrity means Square One bv dba Visual Integrity
- * Software means the Software, media and documentation in the package or download file.

License Grant

You have received executable code and documentation for the Software, either physically or via computer download.

Visual Integrity grants you a nonexclusive license to:

- * Load the Software onto your computer's storage device.
- * Make one copy of the Software for archival purposes, or copy the software onto the hard disk of your computer and retain the original for archival purposes.
