- 1. **Preamble:** XFINIUM SOFTWARE End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity, referred to as "Licensee") and XFINIUM SOFTWARE for the product XFINIUM.PDF CROSS-PLATFORM PROFESSIONAL EDITION which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and XFINIUM SOFTWARE, (referred to as "Licensor"), and it supersedes any prior proposal, representation, or understanding between the parties. - 2. **License Grant:** Licensor hereby grants Licensee a Non-assignable & non-transferable, Commercial, Royalty free, Non-exclusive license, all with accordance with the terms set forth and other legal restrictions set forth in 3rd party software used while running the SOFTWARE PRODUCT.
- 2.1. The SOFTWARE PRODUCT is licensed per individual developer. You may make copies on more than one computer, as long as the use of the SOFTWARE PRODUCT is by the same developer. The Corporate License allows an unlimited number of developers at a single Licensee location.

- 2.3. **Non Assignable & Non-Transferable:** Licensee may not assign or transfer his rights and duties under this license.
- 2.4. **Commercial, Royalty Free:** The redistributable assemblies can be distributed as a part of a larger work containing more than the SOFTWARE PRODUCT without any royalties.
- 2.5. **With support & maintenance:** Licensor shall provide Licensee a support and maintenance subscription. The support subscription is valid for 1 year from the date of license purchase. Upon the expiration of current support subscription, a new support subscription can be purchased. Support is provided via electronic mail and on regular business days and hours.
- 3. **Term & Termination:** The Term of this license shall be until terminated. Licensor may terminate this Agreement, including Licensee's license in the case where Licensee:

- 4. **Upgrades, Updates and Fixes:** Licensor may provide Licensee, from time to time, with Upgrades, Updates or Fixes, as detailed herein and according to his sole discretion. Licensee hereby warrants to keep the SOFTWARE PRODUCT up-to-date and install all relevant updates and fixes. Licensor shall provide any Upgrade, Update or Fix free of charge for the duration of the subscription period.
- 4.1. **Upgrades:** for the purpose of this license, an Upgrade shall be a material amendment in the SOFTWARE PRODUCT, which contains new features and or major performance improvements and shall be marked as a new version number. For example, should Licensee purchase the SOFTWARE PRODUCT under version 1.X.X, an upgrade shall commence under number 2.0.0.
- 4.2. **Updates:** for the purpose of this license, an update shall be a minor amendment in the SOFTWARE PRODUCT, which may contain new features or minor improvements and shall be marked as a new sub-version number. For example, should Licensee purchase the SOFTWARE PRODUCT under version 1.1.X, an update shall commence under number 1.2.0.
- 4.3. **Fix:** for the purpose of this license, a fix shall be a minor amendment in the SOFTWARE PRODUCT, intended to remove bugs or alter minor features which impair the SOFTWARE PRODUCT's functionality. A fix shall be marked as a new sub-sub-version number. For example, should Licensee purchase the SOFTWARE PRODUCT under version 1.1.1, a fix shall commence under number 1.1.2.
